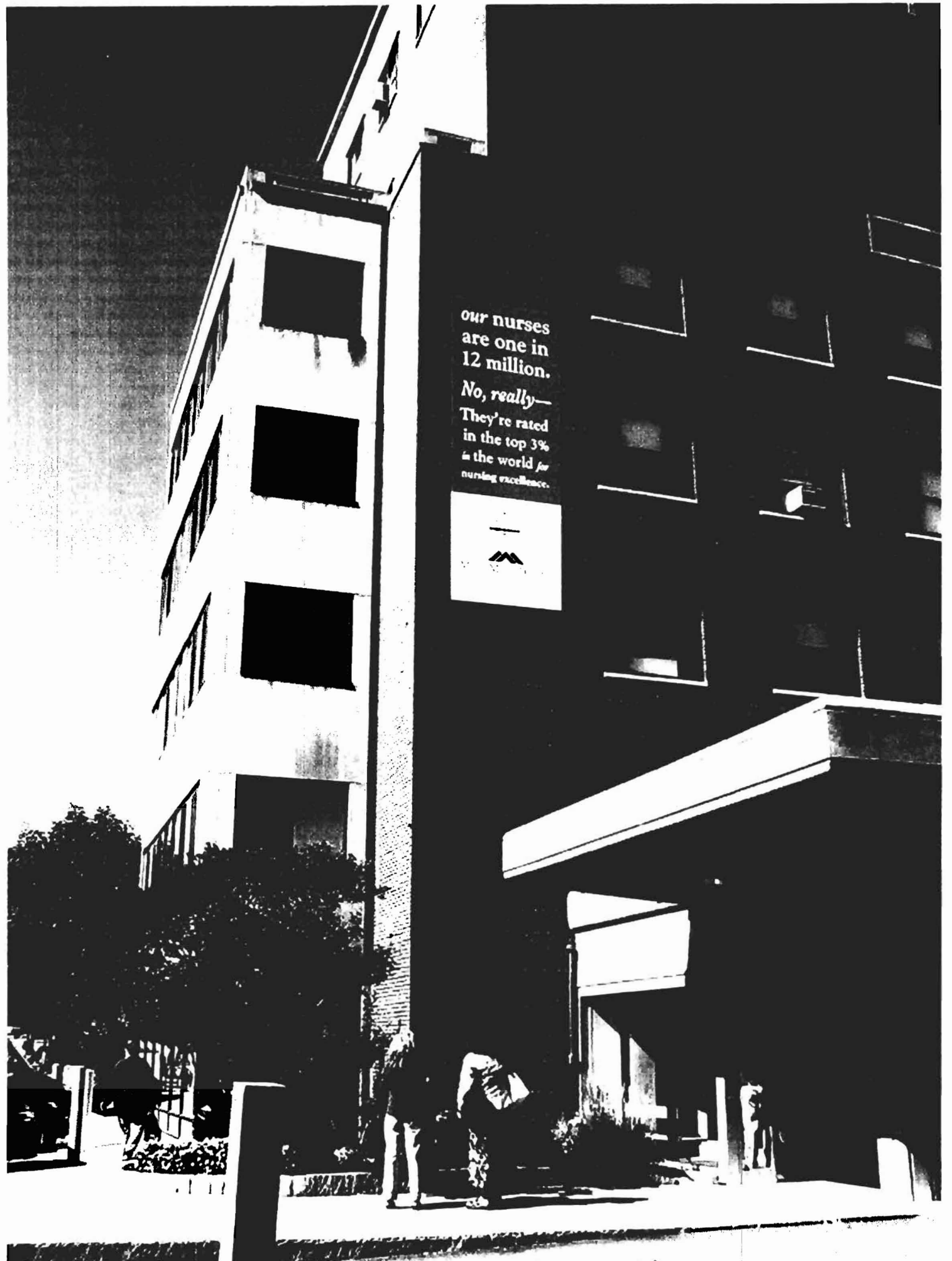

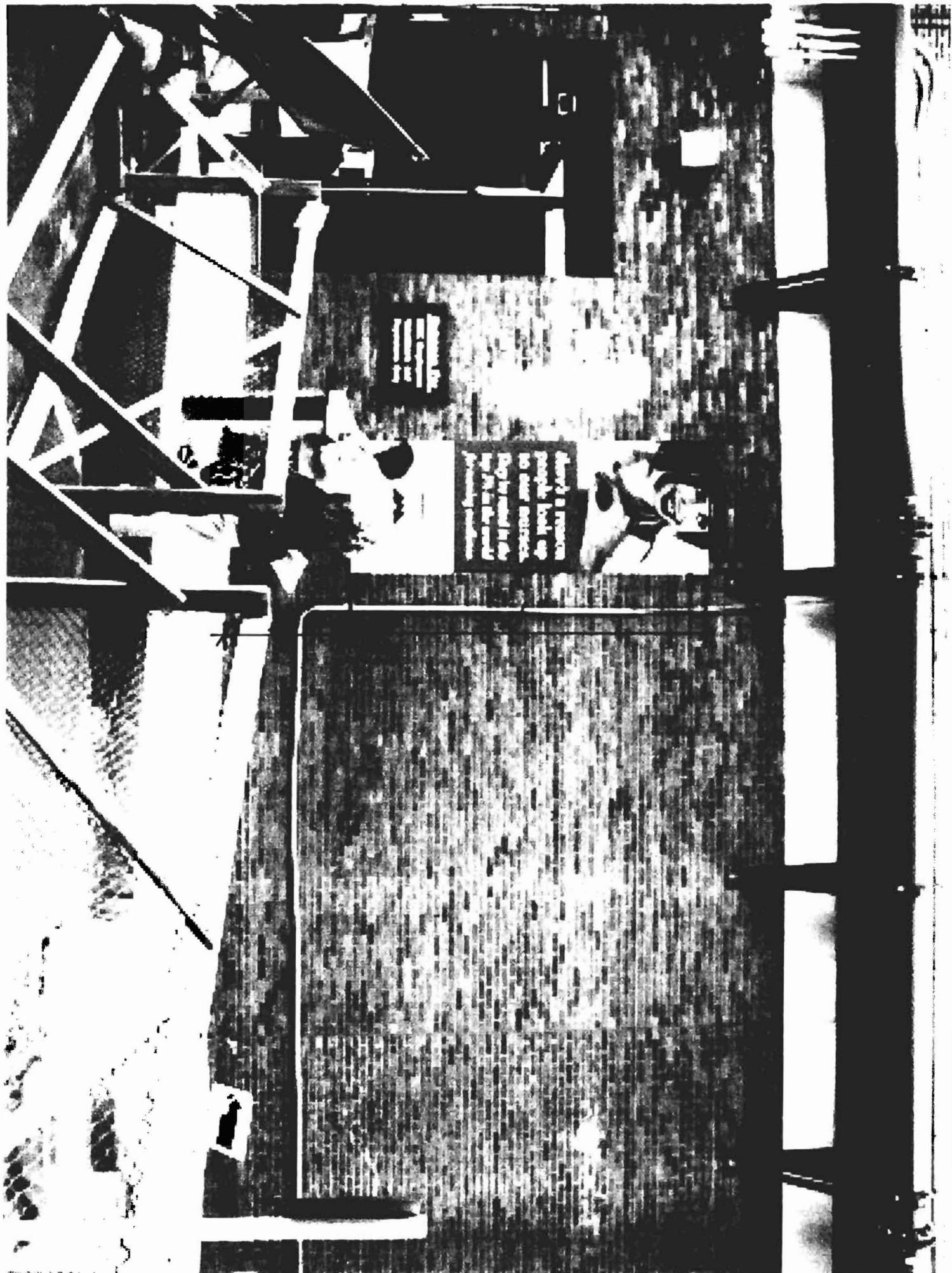

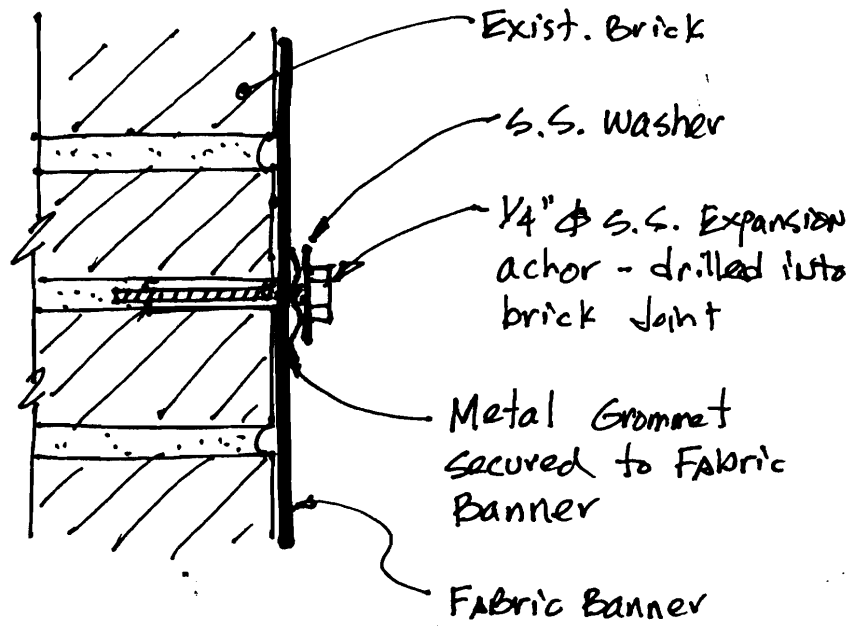
Hi Wayne.
