



    - » No parking on Boynton St temporarily to allow for emergency vehicle access
- Outbound:

- Flaggers and Police where appropriate











#### **MINUTES**

AG/RD reviewed the details and duration of the closure of Congress St.

- 1. METRO identified the following acceptable responses to the closure of Congress St.
  - a. Metro will close 4 bus stops for the duration of the Congress St closure listed below. MMC will be responsible for placing temporary signage on the bus stop signs that say the stops are closed.
    - i. East Bound: Congress/Gilman & Congress/Weymouth
    - ii. West Bound: Congress/Weymouth & Congress/Valley
  - b. Metro will temporarily relocate their East Bound stop on Park/Weymouth to approximately 50 feet West on Park (at or just West of an existing utility pole) to avoid the intersection of Park/Weymouth and impacts to the temporary signal. One parking spot will be temporarily taken out of service for this duration. The parking spot is currently limited to 1 hour during daytime hours. MMC will make the necessary improvements to ensure this temporary stop meets ADA requirements this includes providing paved access from the curb to the sidewalk.
  - c. These temporary changes will be jointly communicated by MMC and Metro ahead of implementation.
- 2. MMC will follow up with Metro after a conversation with the Seadogs re: queuing of buses on Park.

MaineDOT held a meeting of the Tameing to discuss the subject project.

MaineDOT through explanation from Maine Medical center, their consultants and city staff agree that the closure is necessary to perform the work. We realize that in order to perform the work Maine Medical Center will need to do several things for mitigation including turning some city streets one Way, adding a traffic signal at Park Ave and Weymouth and maintain a consultant and contractor to perform timing changes on the city's traffic signals in the vicinity. MaineDOT will allow Maine Medical Center to place Changeable Message Signs on I-295 to inform the traveling public of the closure. Other CMS should be place on Congress St. Maine Medical center will work to provide communications out to the traveling public regarding the closure and to specifically communicate when The Sea Dogs have games during the time of this closure. MaineDOT is of the understanding that this closure will be 8 weeks max and the roadway will be open to traffic prior to the 4<sup>th</sup> of July.
