Hi Nell - The only other time I recall doing this was in the Verdante development and we added it to the license itself. So, attached is an additional redline with that language added. The only other change I made was to (now) paragraph 4 relating to indemnity. The language of that paragraph has been tweaked a number of times and the changes made by MMC and by me seem to have resulted in some disjointed language. So, I've replaced the whole of that paragraph with language from a prior version that, I think, represents a clear and agreeable provision. If, however, MMC wants to further clarify, please invite them to do so. If not, I've also attached a clean version that they can sign. They can then send the original to me and I'll send it along to Brendan for his consideration. In the meantime, it might make sense for you to give him a heads up that this is coming and to explain the proposed amount so that you can work through any questions he might have.

Will this work? Happy to talk if there are any questions.

Assuming Bill is okay with the exhibit and the description, my only comment would be that we do need to resolve the financial element of this, as we've required compensation for overhangs above the ROW in the past. When I take the figures that they've provided in the exhibit here and run the numbers based on assessed value, I get the following:
