Jeremiah,

I have been anticipating a conversation about the one-ways on the West End during the Congress St site plan review. Below is a tentative scope of work for the traffic analysis. Can you confirm that this is what you're expecting for this analysis? Also, can you recommend the best week to complete this work between now and September 1?

## Study will include:

- 1. Modifying Bramhall Street to be one-way southbound (starting at Chadwick)
- 2. Modifying Chadwick Street to be one-way southbound (between Bramhall and West)
- 3. Incorporating appropriate pedestrian signage at the intersection of Bramhall and Chadwick and the intersection of Bramhall and Vaughan
- 4. Other actions that may help to improve access, circulation and safety conditions in the area.

## Study area includes:

- 1. Bramhall Street/Congress Street
- Bramhall Street/Vaughn Street
- 3. Bramhall Street/Brackett Street/Charles Street
- 4. Bramhall Street/Chadwick Street
- 5. Chadwick Street/MMC Surface Lot Drive
- 6. Chadwick Street/West Street
- 7. Vaughn Street/West Street
- 8. Vaughn Street/Brackett Street

## Method of study:

- Peak hour traffic counts: New counts would need to be collected at some locations. [is there data readily available that might reduce this effort?]
- Site Observations: peak period site observations to better understand traffic flow conditions, including those generated by patients, staff, the surrounding community, pedestrians, bicycles, etc.

## Deliverables will be:

- PowerPoint Presentation summarizing the goals/objectives of the study, baseline assumptions, existing conditions, future conditions, findings, and next steps.
- Preliminary Concept Plans Up to two (2) alternative conceptual plans would be developed and could include possible add-alternate sub-concepts at some locations if determined to be appropriate. The purpose of developing these images is to demonstrate the lane use needs required to support intended access changes and that these changes can fit within defined right-of-way. These will be CAD-drawn line work overlaid onto a dimensioned, high-resolution aerial photograph that will be supplied to VHB by MMC. Detailed illustrative concept plans are not included as part of this scope of services now.
- Next Steps: a formulation of key next steps to be considered

Jeremiah/All,

To provide some background on this -

MMC's IDP includes a section they called 'Future Transportation Considerations," that reads like this:

MMC continues to solicit input from its neighbors to identify transportation-related issues and possible improvements that should receive additional consideration during the planning and design of future projects by MMC and the City. Key issues identified in this process to date include the following:

- Chadwick Street: A portion of Chadwick Street is one-way. The conversion to two way could reduce the amount of traffic going further into the West-end neighborhood and help slow vehicular speeds to levels that are safer for pedestrians and bicyclists.
- <u>Chadwick Street at West Street:</u> Neighbors have observed low compliance with stop signs and two-way travel on one-way streets.
- <u>Vaughan Street at Bramhall Street:</u> This is a difficult intersection geometry for pedestrians, cyclists and vehicles.

Given the above, I think he's mixed up on the scope (see points 1 and 2 below) at the very least, and we may want to include a point about Vaughan/Bramhall in the scope?

You may also have other issues you'd like to see addressed?

Good Afternoon AI,

The general scope of the study proposed appears solid - thank you.

As for the components, the bread crumbs can be traced back to some of the discussion in the IPD's "Future Transportation Considerations"

In essence, as MMC moves to a different site and access plan, the City's desire is to see the immediate West End neighborhood become more permeable to all modes of travel, with vehicle and pedestrian access in particular.

In particular, an examination of the one-way sections of Chadwick and Bramhall Streets with a goal to convert to two-way flow has been identified.

In addition, safety and compliance with traffic control should be examined at Chadwick and West Street.

The intersection of Chadwick and Bramhall should be examined and recommendations/designs completed for a more standardized geometry and approach angles.

Not noted in the IDP, but with similarities to Chadwck/Bramhall, Vaughan at Bramhall also has geometric issues and should be evaluated for geometrics, an alternative alignment, and appropriate traffic control.

Lastly, significant transportation infrastructure in the immediate vicinity of the campus should be examined for significant barriers. For example, DPW has identified a stairwell on the sidewalk in front of MMC's Cardiothoracic Surgery facility at 818 Congress. The potential of removing this barrier should be explored.
