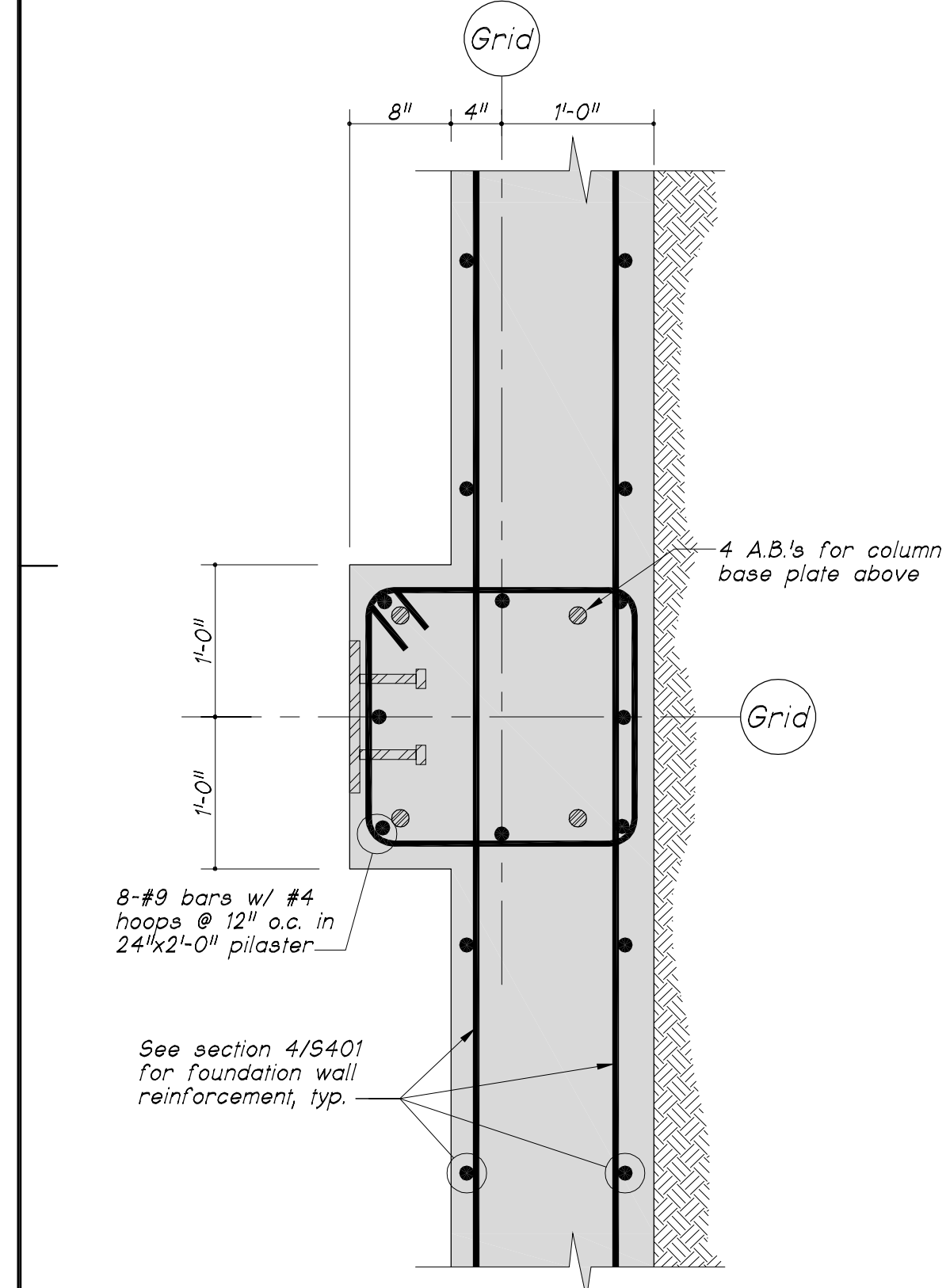
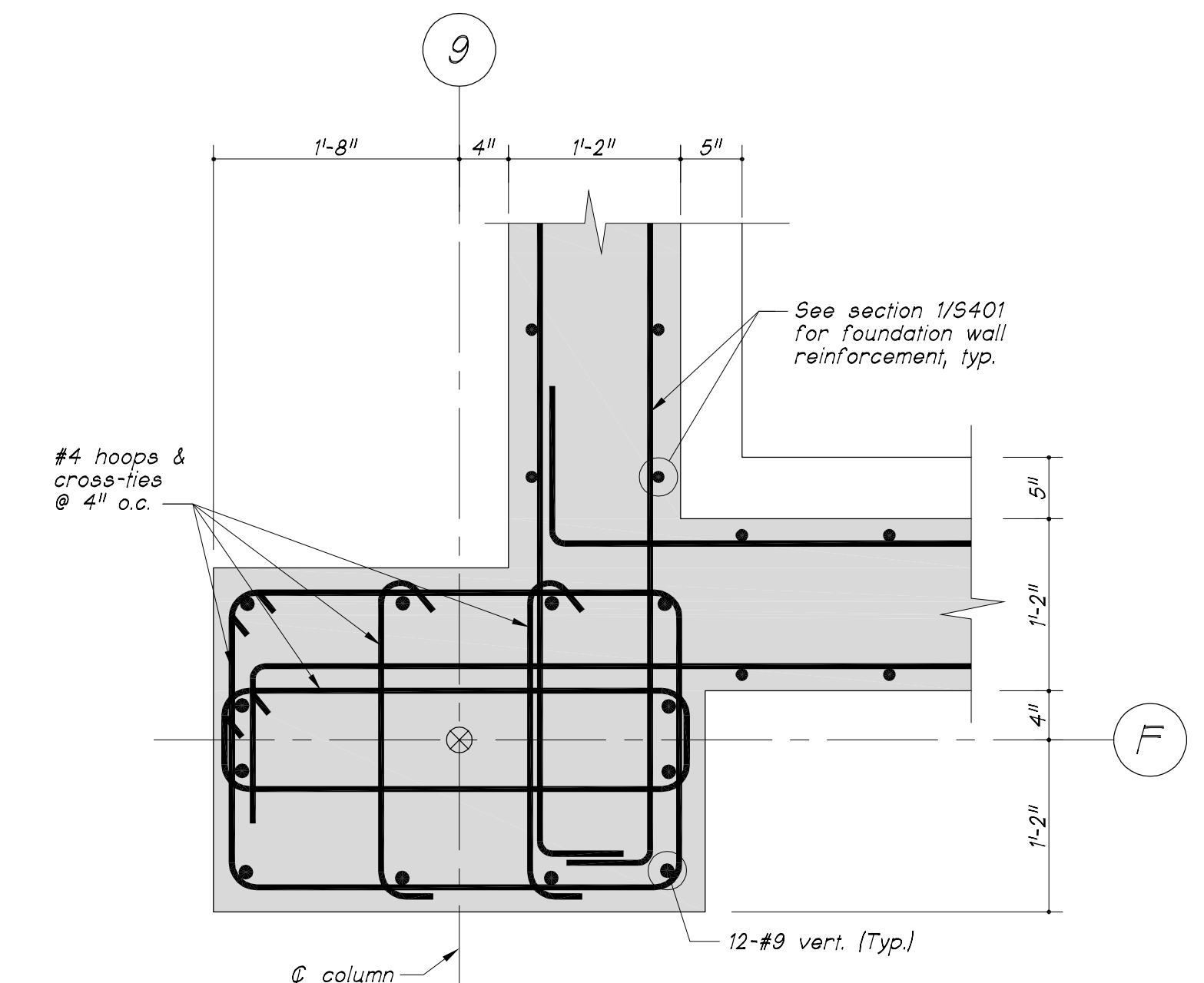


1 PIER P1

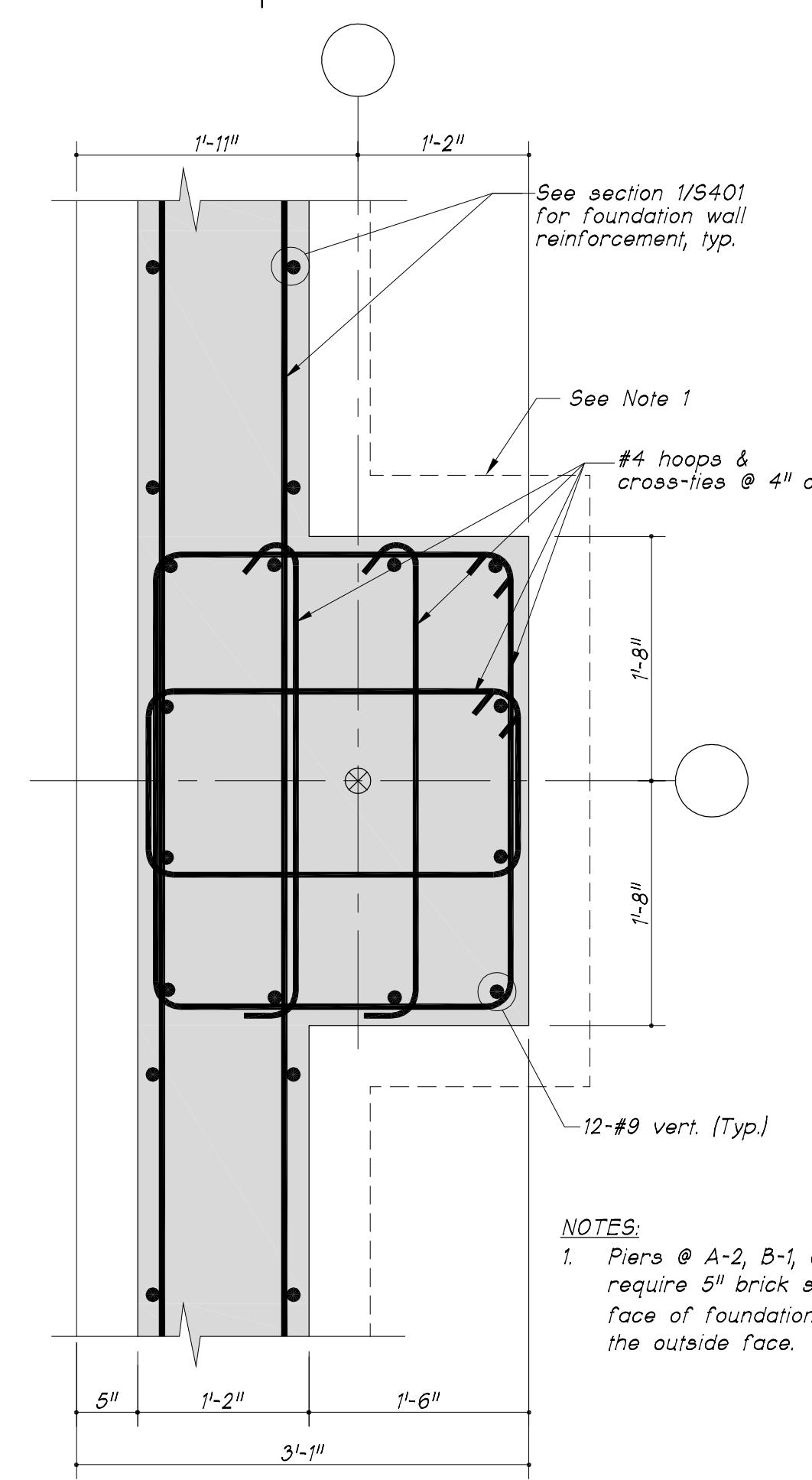
2 PIER P2

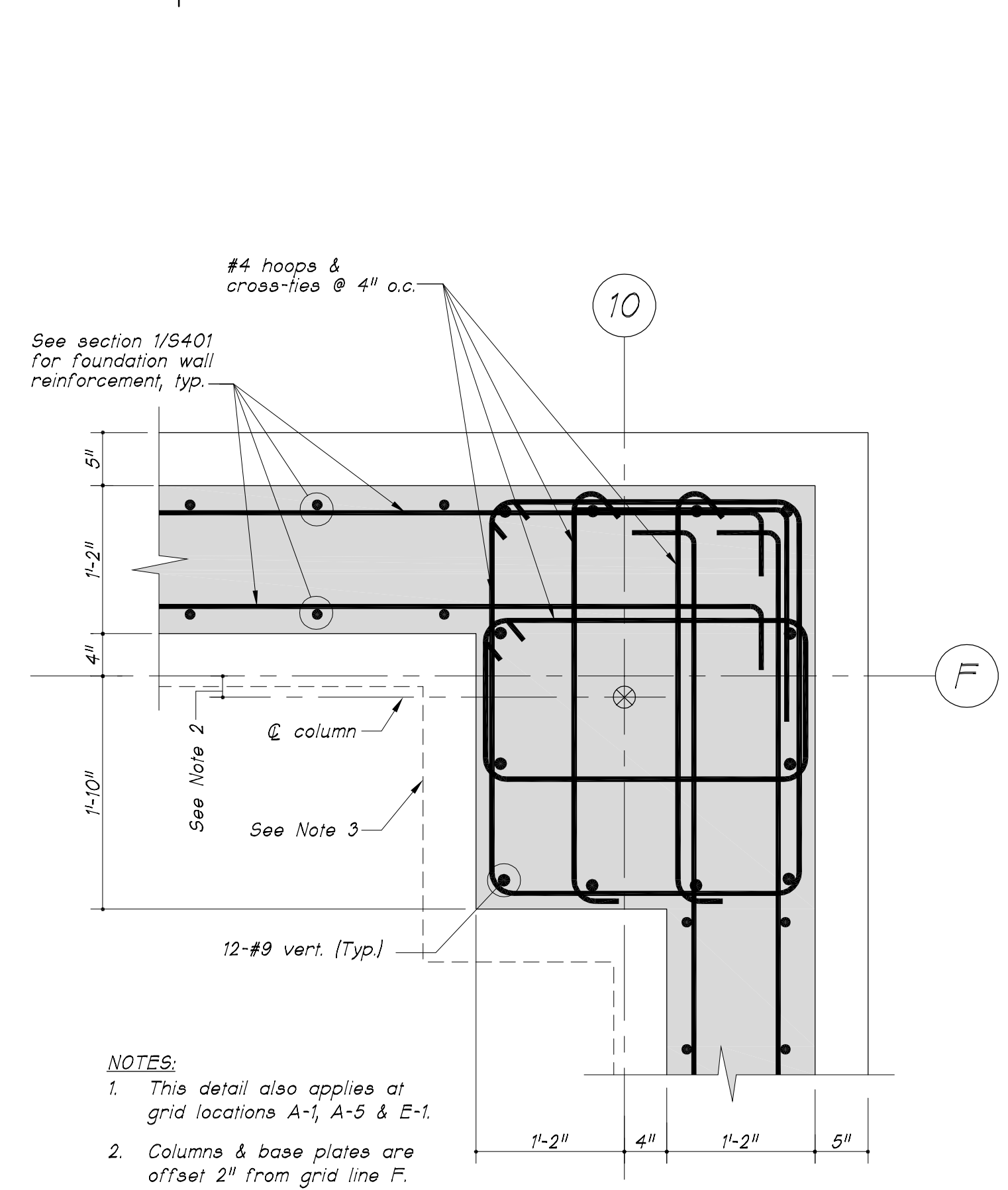
7 PIER P7

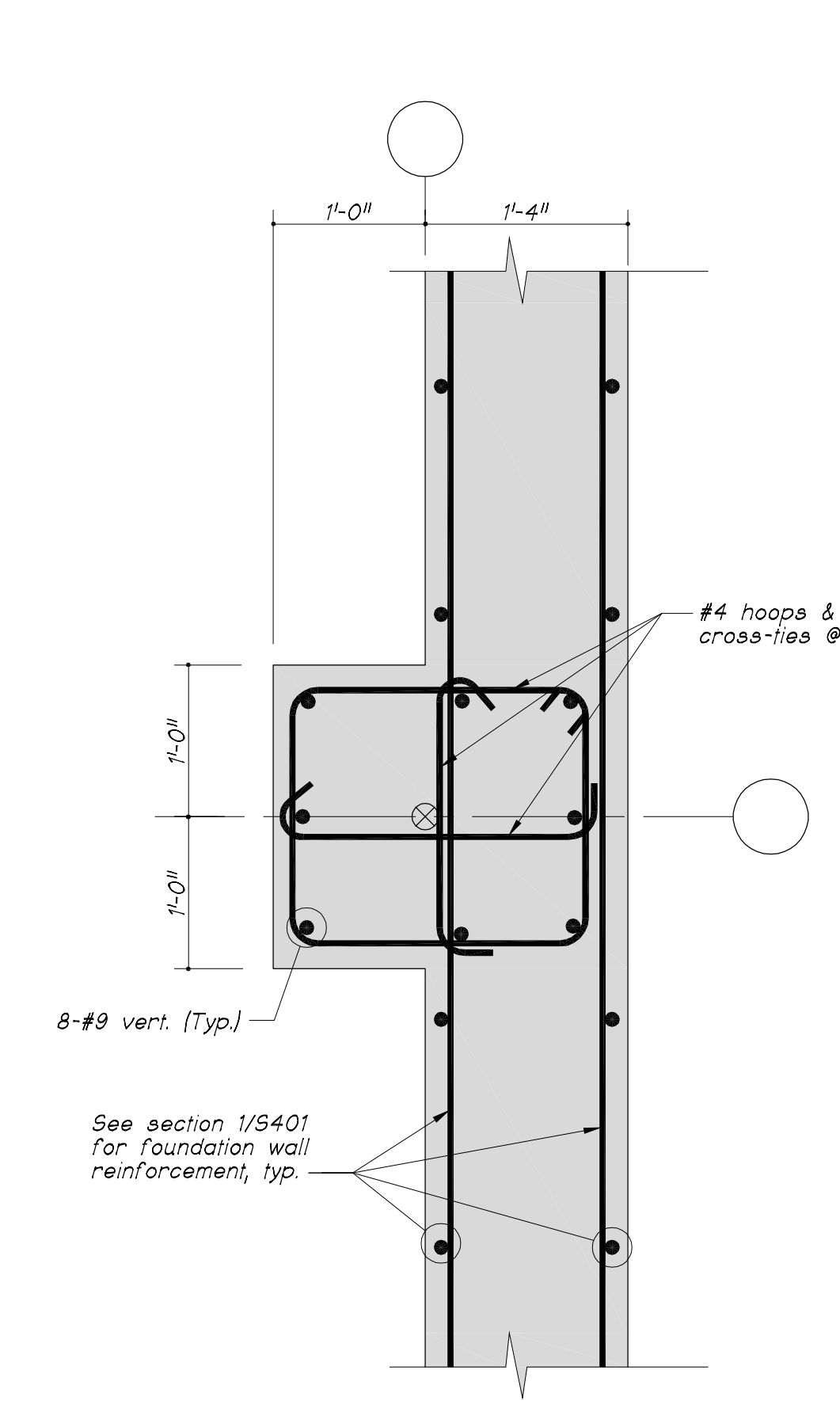

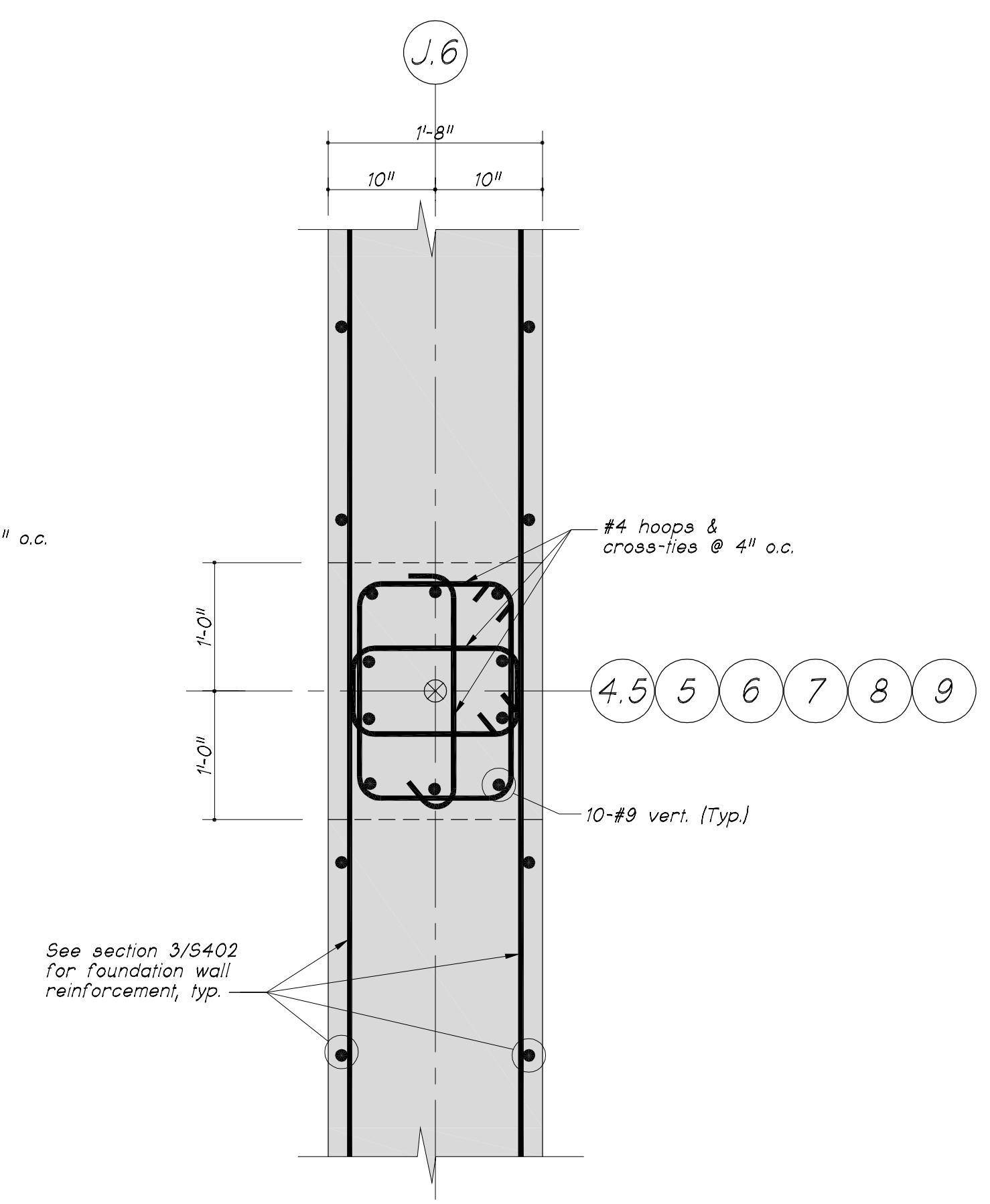

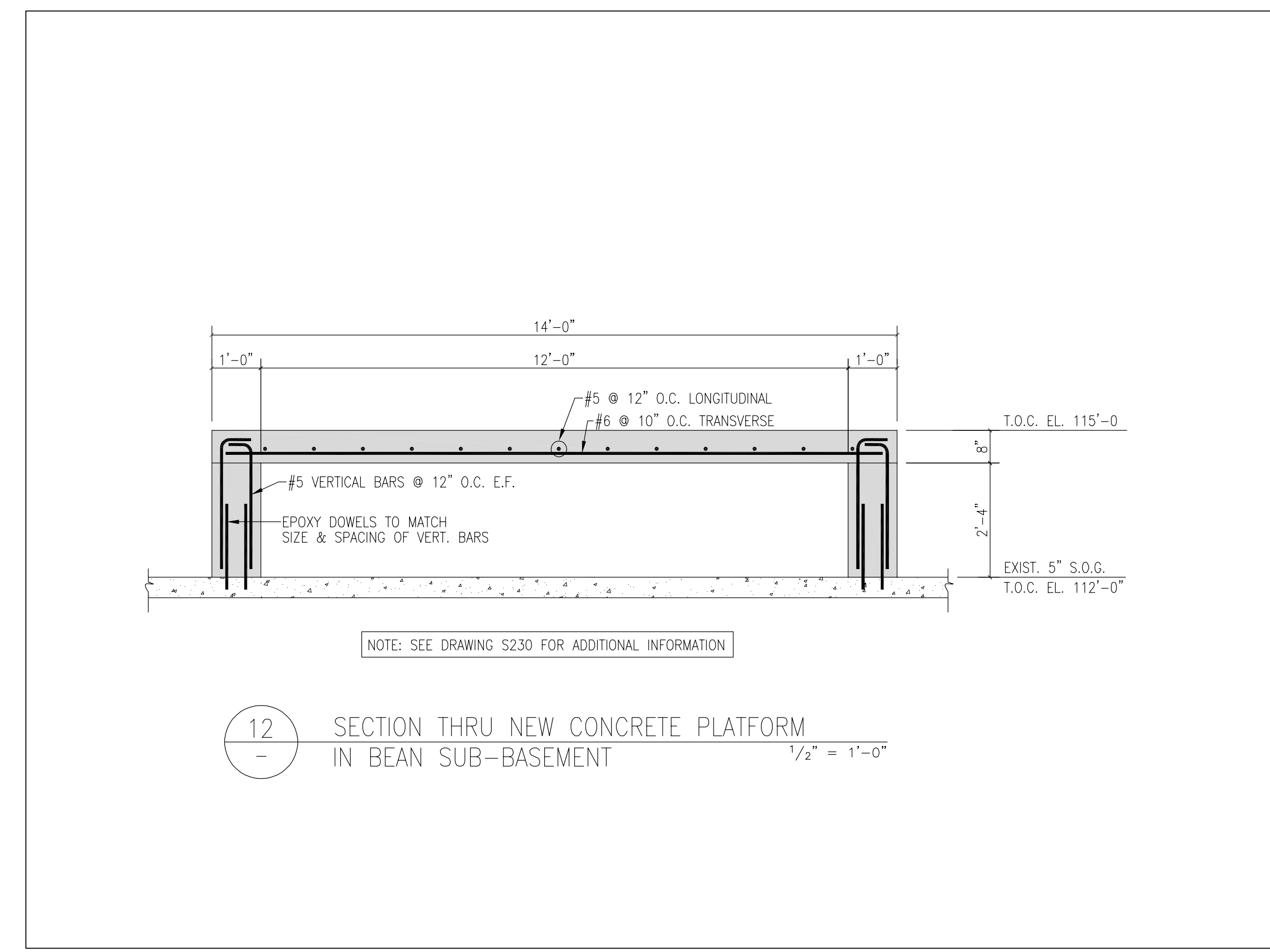
