Building Inspections:

This is an application to convert my four unit building on Russell st. into condominiums. My lawyer is away for two weeks so I have filled out the application and attached the other required documents in an attempt to expedite the process. I realize there will be mistakes. Please feel free to contact me and I will do my best to provide any necessary information or correct mistakes.

Attached you will find the condominium application, interior/exterior plans from the surveyor as well as letters to the tenants.

I do not believe I need to fill out the general building permit application.
I am not sure if the current tenants are eligible for financial assistance.

There are currently only two tenants. The reason for this is that my units were grossly under market value. I had not raised the rents in four years. I had given the tenants notice in December that I would be raising the rents as of February 1. Two of the tenants decided not to renew their lease. At that point I decided, since I needed to fix up the units regardless, to convert the building into condominiums.

I do not have the forwarding information for one of the tenants since they used their security deposit to cover their last months' rent.
