Every permit requires a certain review process. Once a permit has been issued, the fees and all associated items with it have been completed, like the permit itself. Conversions and changes of use are more complicated. Changes of use require a Certificate of Occupancy, and a C of O inspection, which typically we do charge for. Your condo conversion was issued back in May. If we review this new change of use from a condo back to a multi-family, it will still require the C of O and completely new charges.

I will check with both Marge and our Inspections Division Director to see what we can do.
