Hello Lannie,

Enclosed is my revised building permit application for the renovations I am planning on 297 Brackett, a small 2 unit near Maine Med.

I initially submitted a permit application on April 24 and would like to start renovations right away as to be out of my current apartment by as close to June 1 as possible.

All changes are on the 2nd floor of the building.

My intention is to:

- Remove some internal partitions
- Leave the existing toilet, remove sink & tub, and add small sink, making it a 1/2 bath
- Move the kitchen sink closer to the stack so as to backvent
- Convert an existing bedroom to a full bath and add new stack
- Run plumbing to the third floor for future renovations
- Remove one of the two stairwells between the 2nd and third floor.
- Expand the two windows on the back corner of the house

The house is in a historic district, but is not on a register, and neither of the windows are viewable from any public street. In the "from Trowbridge" picture, you can see the back corner of the third floor of the house, but not the second floor. There is a 4-foot kneewall below the lowest corner of the roof on the third floor, so the new window would be behind the gable of the dark gray house. Since my time and money is limited, I would like to know right away if staff is unable to approve the window changes so that I can remove them from this application.
