

Hi Shukria and Tom,

Please note that the revised plan accomplishes the following which I heard to be important at our meeting last Wed.

- 1. It requires the setting of only one new pole
- 2. The location of the new pole does not interfere with current pedestrian access nor will it interfere with potential accessibility upgrades at the crosswalks of Carleton and West Street.
- 3. The visibility of the stop sign is not impeded by the placement of the new pole. It is relocated in front of the pole and also closer to the curb which allows it to be visible from both directions on West Street.
