Please find attached the Application for Legalization of Nonconforming Dwelling Units for 90 Pine Street. 90 Pine Street is owned by 90 Pine Street Apartments, LLC of which I am a member. 90 Pine Street has 4 units, 3 of which are legal. I'm submitting this application so as to make the 4<sup>th</sup> unit legal.

90 Pine Street had been foreclosed on and abandoned in the past year. 




