Thank you for sending the revised quote. It looks to be in line with the above conditions that I sent earlier in the summer, which you included in your email. You should be ready to go. Here is a link to the Application for a Certificate of Appropriateness, at the City's website. The application can be sent in by email, and the staff will send you an invoice for the fee.

The clear glass will be fine; I believe the VLT listed on the spec is for the whole window including frames (which don't let in light.) The figure of .7 refers only to the glass itself.

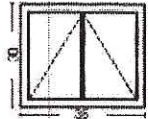
