To secure the horizontal fire barrier between units and bring the ceiling up to code we intend to use 5/8" Fire Code C Core gypsum panels. I have also attached the diagram we used at 87 Emery St two months ago, it shows our current flooring of 1"sub and finished floor

The section of the building code I am referencing is Section 712 Horizontal Assemblies. Given this is a multi-family dwelling unit, the code requires separation both vertically and horizontally between dwelling units. I am questioning if the horizontal assembly is being affected during the construction which would then impact the separation between the unit under renovation and the dwelling unit

- 2. Clarify what the scope of work is associated with the new master bathroom for units 1 & 3? Is the bathroom renovations part of this permit?
- Clarify if the non-bearing partitions being removed will impact the existing ceilings. Given the work being done, continuity of separation of horizontal assemblies is to be maintained.
