START OUT GOING SOUTHWEST ON COCHITUATE RD/RT-30W TOWARD BURR ST. MAPHIDE. MAKE A U-TURN ONTO COCHITUATE RD/RT-30. TAKE THE RAMP TOWARD I-90/MASSPIKE/BOSTON. MERGE ONTO I-90E/MASSACHUSETTS TURNPIKE/MASS PIKE TOWARD I-95/BOSTON (PORTIONS TOLL). TAKE THE I-95N/RT-128N/RT-30 EXIT, EXIT 14, TOWARD N.H.-MAINE/POINTS NORTH. MERGE ONTO I-95N VIA THE EXIT ON THE LEFT TOWARD WALTHAM/PORTSMOUTH NH (PORTIONS TOLL) (PASSING THROUGH NEW HAMPSHIRE, THEN CROSSING INTO MAINE). MERGE ONTO I-295N VIA EXIT 44 TOWARD SOUTH PORTLAND/DOWNTOWN PORTLAND (PORTIONS TOLL). TAKE EXIT 4 TOWARD PORTLAND/WATERFRONT. TURN SLIGHT LEFT ONTO VALLEY ST. TURN SLIGHT RIGHT ONTO DANFORTH ST. ARRIVE AT: 284 DANFORTH ST, ON THE RIGHT.
