Building Permit Application for New Tension Fabric Structure

To Whom It May Concern:

As an Agent of New Yard, LLC (New Yard), we are pleased to provide the accompanying Building Permit application for their proposed building activities at the Canal Landing site. New Yard, LLC is proposing to construct a new tension fabric building structure in support of their proposed boat maintenance operations at the site. The project has previously received Site Plan Approval from the Portland Planning Authority. We have recently made an Amended Site Plan application to the Planning Authority related to the realignment of their initial tension fabric building and expect to receive an Amended Site Plan approval at their October 22, 2013 public hearing. Copies of these permits and applications are on file with the Planning Department. Most recently the City issued Permit 2013-02045 for Phase 1A site work on the project. In accordance with Condition #1 of the permit we also recently submitted an application and supplemental materials for their Phase 1 boat ramp and float systems which are also to be constructed.

This current submission is for the proposed Tension Fabric Structure which is to be used for vessel maintenance. The proposed building is manufactured by Legacy Building Solutions who will be also responsible for the building erection. The tension fabric structure includes a steel member framing system and cast in place concrete foundation system. The proposed structure will measure 120'-0" wide x 160'-6" long. The structure will contain a dry sprinkler system designed by Advanced Fire Protection Services, LLC. We understand that they have just recently submitted a Fire Suppression Systems application for the project. We hope that these application reviews can all run concurrently. The proposed building will contain at least one large overhead door and multiple access doors around the building perimeter to meet code requirements. The largely unheated building will contain a gravel floor throughout except for two corners where the sprinkler riser standpipes will enter into the building space.
