

## Fire Alarm Permit Application Checklist

All of the following information is required and must be submitted. Checking off each item as you prepare your application package will ensure your package is complete and will help to expedite the permitting process.

✓	In order to review revisions to previously submitted plans, each revision shall have the same file name as the previous version
✓	Each document shall be a separate file with a descriptive file name
<b>√</b>	An example of one document and file is a four page data sheet for one smoke detector
<b>√</b>	Designer qualifications (copy of NICET IV certificate or stamped plans and documents)
