Dear Mr. Bushey:

This is in response to your recent request on behalf of your client, Canal Landing, LLC, to modify Department of the Army permit number NAE-2012-02469, that authorized the placement of permanent and temporary fill, performing excavation, and performing other work below the high tide line in the Fore River at Portland, Maine in order to facilitate the development of a new boat yard while also remediating areas of on-site soil contamination.

In response to your request, the permit is hereby modified to authorize a relocation of several of the previously authorized project elements further west on the property and to construct an additional boat ramp and install additional finger floats extending perpendicular from shore. The net impact of these improvements compared to that authorized will be an increase of approximately 278 s.f. of additional fill below the high tide line, 3,958 s.f. of additional subtidal excavation (up to 3,500 cy) with upland disposal, and 10,798 s.f. of additional floats. This work is described on the enclosed plans entitled "LOCATION MAP, CANAL LANDING-NEW YARD EXPANSION, PORTLAND, MAINE" in one sheet dated "FEB 2015" and "CANAL LANDING LLC, 400 WEST COMMERCIAL STREET, PORTLAND, ME 04101" on five sheets dated "OCT. 2017". In support of these improvements and in order to remediate potential threats to local navigation and the marine environment, existing deteriorated pilings and pier remnants will be removed and disposed of at an upland location.

All other terms and conditions of the original permit remain in full force and effect.

This authorization requires that you notify us before beginning the work and that you allow us to inspect the project. You must complete and return the Work Start Notification Form, if not already submitted, to our office no later than two weeks before the work will begin.
