- 1) The fire alarm system shall have a new fire alarm inspection sticker.
- 2) NFPA 1 Fire Code Per 1.14.4 Review and approval by the AHJ shall not relieve the applicant of the responsibility of compliance with this Code.
- 3) Shall meet the requirements of 2009 NFPA 1 Fire Code.
- 4) Shall meet the requirements of NFPA 101 (2009) Ch. 14 New Educational Occupancy
- 5) Fire protection systems shall be maintained. If system is to be off line over 4 hours a fire watch shall be in place. Dispatch notification required 874-8576.
