1. Old Business

A. Variance Appeal:

227-229 York Street, Neil Reiter, leesee, Tax Map 044, Block E, Lot 002, B-1

Neighborhood Business Zone: The applicant is planning to open a restaurant. Three off-street parking spaces are required. The appellant is requesting a variance to waive the off-street parking requirement. Representing the appeal are Tom Landry, the manager for the owner A Better Maine LLC, and the leesee's representative, Stella Hernandez. **The Zoning Board of Appeals voted 3-2 to deny the appeal.**

B. Conditional Use Appeal:

227-229 York Street, Neil Reiter, leesee, Tax Map 044, Block E, Lot 002, B-1

Neighborhood Business Zone: The appellant is seeking a Conditional Use Appeal under section 14-163(a)(1) to open a restaurant. Findings of Fact and Conclusions of Law:

Applicant is seeking a variance for a handicap ramp. The side yard setback in the R-6 zone for two and three-story structures is ten (10) feet, however: "The width of one (1) side yard may be reduced one (1) foot for every foot that the other side yard is correspondingly increased, but no side yard shall be less than ten (10) feet. . . ." Portland City Code §14-139(a)(4)(c).

In this case, applicant seeks a variance to construct a handicap ramp on the side of the principal structure. The applicant is seeking a variance because the side setback will be 37 inches instead of the required ten foot setback.

Disability Variance standard pursuant to Portland City Code §14-473(c)(2):

1. The variance is for the purpose of making the property accessible to a person with a disability who is living on the property. "Disability" has the same meaning as a physical or mental handicap under 5 M.R.S.A. Section 4553, which is "any disability, infirmity, malformation, disfigurement, congenital defect or mental condition caused by bodily injury, accident, disease, birth defect, environmental conditions or illness, and includes the physical or mental condition of a person that constitutes a substantial disability as determined by a physician or, in the case of mental disability, by a psychiatrist or psychologist, as well as any other health or sensory impairment that requires special education, vocational rehabilitation or related services."

Satisfied Not Satisfied

Reason and supporting facts:

Applicant's mother is 95, frail, and requires a wheel chair to enter and exit the applicant's home where she lives.

2. Any variance granted under this subsection shall be solely for the installation of equipment or the construction of structures necessary for access to or egress from the property by the person with the disability.

Satisfied Not Satisfied

Reason and supporting facts:

Variance is for construction and installation of an ADA compliant wheelchair ramp, which may be dismantled and removed when it is no longer necessary.


Conclusion: (check one)

Option 1: The Board finds that the standards described above have been satisfied and therefore GRANTS the application.

Option 2: The Board finds that while the standards described above has been satisfied, certain additional conditions must be imposed to minimize adverse effects on other property in the neighborhood, and therefore GRANTS the application SUBJECT TO THE FOLLOWING CONDITIONS: (Note that the board may limit the variance to the duration of the disability or to the time that the person with the disability lives on the property).

Option 3: The Board finds that the standards described have NOT been satisfied and therefore DENIES the application.



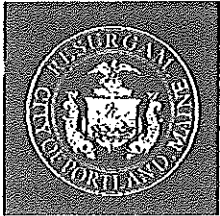

Dear Dr. Crocker & Dr. Garcia,

You applied for a permit to build a ramp to make your property at 13 Carroll Street handicap accessible for one of your family members. This property is located in the R-6 residential zone. The required side yard setback is ten (10) feet [section 14-139(a)(4)(c)]. The plot plan submitted November 2, 2012 gives the side yard setback from the ramp as 4'10". Since the proposed ramp does not meet the side setback requirement, you will need to apply for a Disability Variance. Since the ramp has to be installed immediately, I am signing off on the ramp for Zoning and moving the permit forward in the review process to Historic Preservation. You will need to apply for a Disability Variance within thirty days of the permit being issued.


