Miller by deed dated September 15, 1960 and recorded in Cumberland County Registry of Deeds in Book 2547, Page 205; said point being One Hundred Twelve and Forty-two Hundredths (112.42) feet Southerly from the intersection of the Easterly sideline of Vaughan Street with the Southerly sideline of Carroll Street; thence Easterly parallel with the Southerly sideline of Carroll Street and by said Miller land Two Hundred and Five Tenths (200.5) feet to the Westerly sideline of land now or formerly of W.H. Clifford Company; thence Southerly parallel with the Easterly sideline of Vaughan Street and by said land of W.H. Clifford Company, Seventy (70) feet, more or less, to the Northerly sideline of land conveyed by the Corporation of the Presiding Bishop of the Church of Jesus Christ of Latter-day Saints to Second Parish of Portland, by deed dated August 3, 1964 and recorded in said Registry of Deeds in Book 2844, Page 73; thence Westery parallel with the Northerly sideline of Clifford Street and by said land of Second Parish of Portland and by land conveyed by Burnell Poole, Jr., et al., to Porter D. Leighton, et al. by deed dated May 26, 1966 and recorded in said Registry of Deeds in Book 2958, Page 683, Two Hundred and Five Tenths (200.5) feet, more or less, to the Easterly sideline of Vaughan Street; thence Northerly by the Easterly sideline of Vaughan Street Seventy (70) feet to the point of beginning.
