Hi Doreen, Brad and Emily -

To follow up again on your email of 6/13 in response to mine of 6/11, I am now able to complete the application for a building permit to move the stairs on our ground floor, south side back deck.

The work to be done by Dave Semon of Gulf of Maine Custom Homes is as follows:

1. Remove stairs on back deck for unit 1; save for reuse.

2. Extend ledger on building out to edge of deck. Fill in existing stair opening. Install decking on new framing, matching existing as closely as possible.

3. Remove railing from back of deck; install across front.

4. Attach old stairs to back of deck. Install new railing for deck and stain.*

5. This price does not include obtaining a building permit.

* We will make sure that this includes a hand rail to match the one on the steps for unit 2 opposite.

Project cost, \$1,152

Since this is a smaller, simpler project, I will come in to present the documentation to you, ask you to kindly scan the few documents and for me to pay the permit fees and answer any questions.

Preservation compliance coordinator Rob Wiener met with me at the building on May 11 and took photos of the deck in question. He said he could forward them to you.

Various small repairs of rotten wood on railings and spindles of deck for unit 1. \$385.

Move steps to deck for unit 1 from area inside the railing to outside the railing on the north side of the deck toward the center of the building to more closely match the arrangement of the steps for

I hope that you might be able to do this work in late July or early August.

In the meantime, I am preparing to apply for the building permit. We already have approval from the Historic District Commission.
