Exhibit A

A certain lot or parcel of land, with the buildings thereon, situated on the easterly side of Vaughan Street, in the City of Portland, County of Cumberland and State of Maine, bounded and described as follows:

Beginning on the easterly side line of Vaughan Street at a point one hundred twenty (120) feet southerly thereon from the southerly side line of West Street and at the southwesterly corner of land conveyed by H. Warren Paine to Joseph D. Rourke, et al, by deed dated November 23, 1959 and recorded in Cumberland County Registry of Deeds in Book 2512, Page 246;

Thence easterly parallel with West Street and by said Rourke land, one hundred (100) feet to the westerly side line of land conveyed by J. B. Brown & Sons to Carrie A. N. Strout by deed dated May 22, 1906 and recorded in said Registry of Deeds in Book 787, Page 275;

Thence southerly parallel with Vaughan Street and by said Strout land, sixty (60) feet to the northerly side line of land conveyed by Grace Porter Thompson to Laban W. Leiter by deed dated December 1, 1954 and recorded in said Registry of Deeds in Book 2204, Page 499;

Thence westerly parallel with West Street and by said Leiter land, one hundred (100) feet to the easterly side line of Vaughan Street;

Thence northerly by the easterly side line of Vaughan Street, sixty (60) feet, more or less, to the point of beginning.

Being the same premises in which Laban W. Leiter, Personal Representative of the Estate of Iva F. Leiter conveyed a life estate to Laban W. Leiter by deed dated October 1, 2014 and recorded in Cumberland County Registry of Deeds in Book 31831, Page 39. The said Laban W. Leiter died testate July 1, 2016. Reference is made to Cumberland County Probate Court Docket No. 2016-1126. The Grantors herein are all the children of Iva F. Leiter who died testate September 12, 2012. Reference is made to the Estate of Iva F. Leiter, Cumberland County Probate Court Docket No. 2012-1350, closed by filing of a Sworn Statement of Personal Representative May 14, 2015.
