This office has reviewed and approved your request on behalf of the West Street Condo Association, to repoint several sections of brick wall at 50 West Street. Approval is subject to the following condition:

• Approved mortar sample was agreed on during site meeting on 10/17/13. Contractor is to forward to Historic Preservation staff the formula used, and also shall give formula to building owners for future reference.

All improvements shall be carried out as in the application and specifications submitted to staff on 10/9/13, and as described in the site meeting at 50 West Street on 10/17/13, except as to comply with the condition above. Changes to the approved plans and specifications and any additional work that may be undertaken must be reviewed and approved by this office prior to construction, alteration, or demolition. If, during the course of completing the approved work, conditions are encountered which prevent completing the approved work, or which require additional or alternative work, you must apply for and receive a Certificate of Appropriateness or Non-Applicability PRIOR to undertaking additional or alternative work. This Certificate is granted upon condition that the work authorized herein is commenced within twelve (12) months after the date of issuance. If the work authorized by this Certificate is not commenced within twelve (12) months after the date of issuance or if such work is suspended in significant part for a period of one year after the time the work is commenced, such Certificate shall expire and be of no further effect; provided that, for cause, one or more extensions of time for periods not exceeding ninety (90) days each may be allowed in writing by the Department.
