### We propose to furnish and install the following:

1. 8 L.F. of 4' high Yorktown style fence. We will use 5" x 5" posts with pyramid caps. All the material will be a first grade white cedar.
2. 1 - 5'1/2" high x 3' wide cedar swing gate. The top 12" of the gate is to be western red cedar lattice.

We will stick build one small panel on site with 5" square posts.
