On Friday, May 15, 2015 I hand delivered a formal complaint about Danny Cook of 26 A St. Room C interfering with our pest control measures.

The sentence: "I will provide you with Mr Ciriello's reports for the May 15, 2015 treatment, findings, and incident, as soon as I receive them." should read:

"I will provide you with Mr Ciriello's reports for the May 14, 2015 treatment, findings, and incident, as soon as I receive them.

I have enclosed a corrected and signed copy, of the formal complaint that I am making.


I am also enclosing a copy of an email that I received over the weekend from Mr Ciriello, owner of Buggy's Pest Control Company.

As you can see both he and his staff are regularly being harassed and abused and interfered with, in trying to treat my building.

I have also inclosed pictures of the latest interference and tampering with the monitor traps. These new monitors were place in Room C on 5/14/15, and the pictures were taken the morning of 5/19/15. So I will add this as another incidence of interference, in addition to those of my original complaint dated May 15, 2015.

I am also awaiting further paperwork on the the last treatment and will forward that as soon as I receive it.

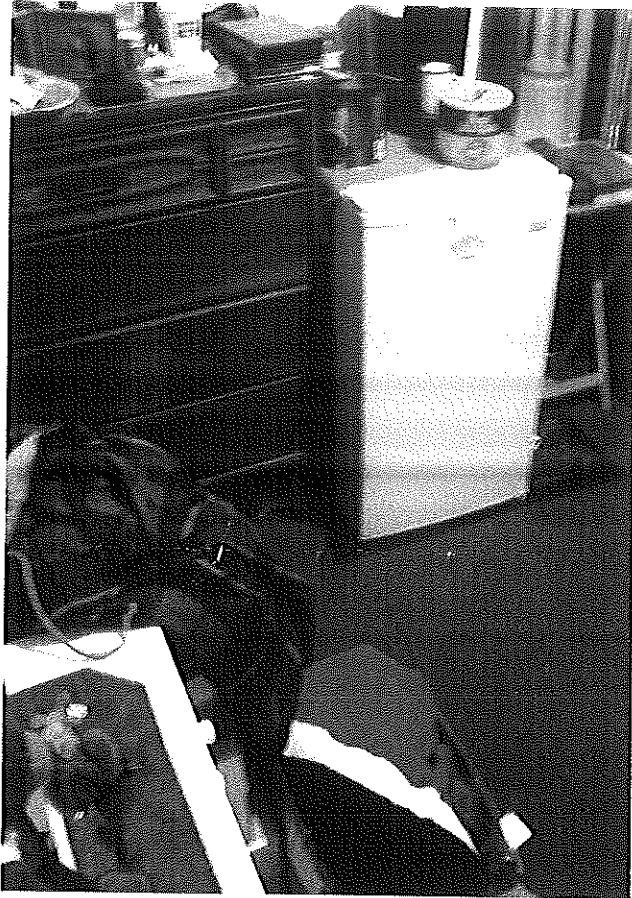

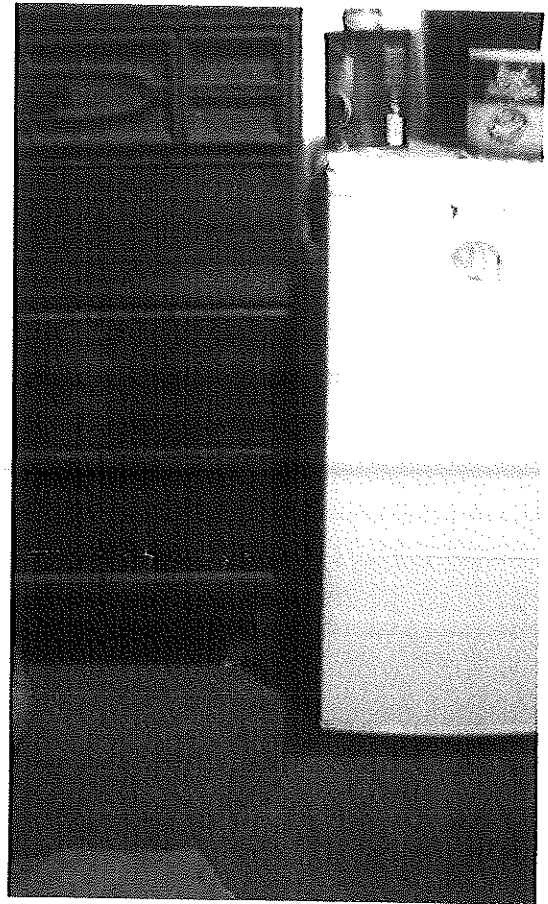
