



GENERAL NOTES

1. THE GENERAL CONTRACTOR IS REQUIRED TO VERIFY ALL DIMENSIONS PRIOR TO THE START OF CONSTRUCTION AND IDENTIFY ANY DISCREPANCIES TO THE ARCHITECTS.
2. ALL WORK SHALL CONFORM TO ALL GOVERNING CODES AND ORDINANCES UNDER WHICH THEY ARE PERFORMED.
3. IT SHALL BE THE GENERAL CONTRACTORS RESPONSIBILITY AS COORDINATOR TO CHECK ALL DIMENSIONS AND DETAILS ON SHOP DRAWINGS BEFORE SUBMISSION TO THE ARCHITECT.
4. FIGURED DIMENSIONS TAKE PRECEDENCE OVER SCALED DRAWINGS. EXCEPT WHERE NOTED, ALL DIMENSIONS ARE TAKEN FROM FACE OF STUD (FOS).
5. ALL EXTERIOR LIGHTING AND NET AREA LIGHTING TO INCLUDE MANUFACTURERS WATER TIGHT HOUSINGS.
6. ALL EXPOSED MECHANICAL GRILLS, DIFFUSERS, ETC. ARE TO BE PAINTED TO MATCH ADJACENT AREAS.
7. THE GENERAL CONTRACTOR SHALL COORDINATE WITH THE OWNER ALL LOCATIONS FOR ANY COMMERCIAL CONDUIT & WIRING SYSTEMS (INCLUDING, BUT NOT LIMITED TO, A.V., LAN & DATA, SECURITY AND LOW VOLTAGE WIRING).
8. THE GENERAL CONTRACTOR SHALL COORDINATE WITH THE OWNER ALL LIGHTING TO BE CONTROLLED BY DIMMERS AND THE LOCATION OF DIMMER CONTROLS.
9. ALL LIGHT FIXTURES DESIGNATED AS TO BE REUSED ON THIS PROJECT SHALL BE CLEANED, RE-LAMPED, AND BROUGHT TO A "LIKE-NEW" CONDITION.
10. ALL EXISTING HVAC FIXTURES AND DUCTWORK DESIGNATED TO BE REUSED, SHALL BE CLEANED AND REPAIRED TO A "LIKE-NEW" CONDITION.

WORKING NOTES

1. COORDINATE VENT HOOD WITH MECHANICAL CONTRACTOR & EQUIPMENT SUPPLIER.
2. GENERAL CONTRACTOR TO COORDINATE MENU BOARD POWER REQUIREMENTS AND FINAL LOCATION WITH EQUIPMENT SUPPLIER AND OWNER.
3. EXISTING DIFFUSER/GRILL TO BE RELOCATED. SEE GENERAL NOTE 10 ABOVE.
4. EXISTING LIGHT FIXTURE TO BE CLEANED, REPAIRED AND RELOCATED.
5. EXISTING FIXTURE TO REMAIN. SEE GENERAL NOTE 9 ABOVE.
6. EXISTING CEILING TO REMAIN. PATCH AND REPAIR AS REQUIRED. PAINT AS PER PLAN.
7. NEW POTRACK (FA-B). SECURE TO STRUCTURAL MEMBERS ABOVE. REFER TO STRUCTURAL DRAWINGS.
8. EXISTING EXTERIOR LIGHTS TO REMAIN. SEE GENERAL NOTE 9 ABOVE.
