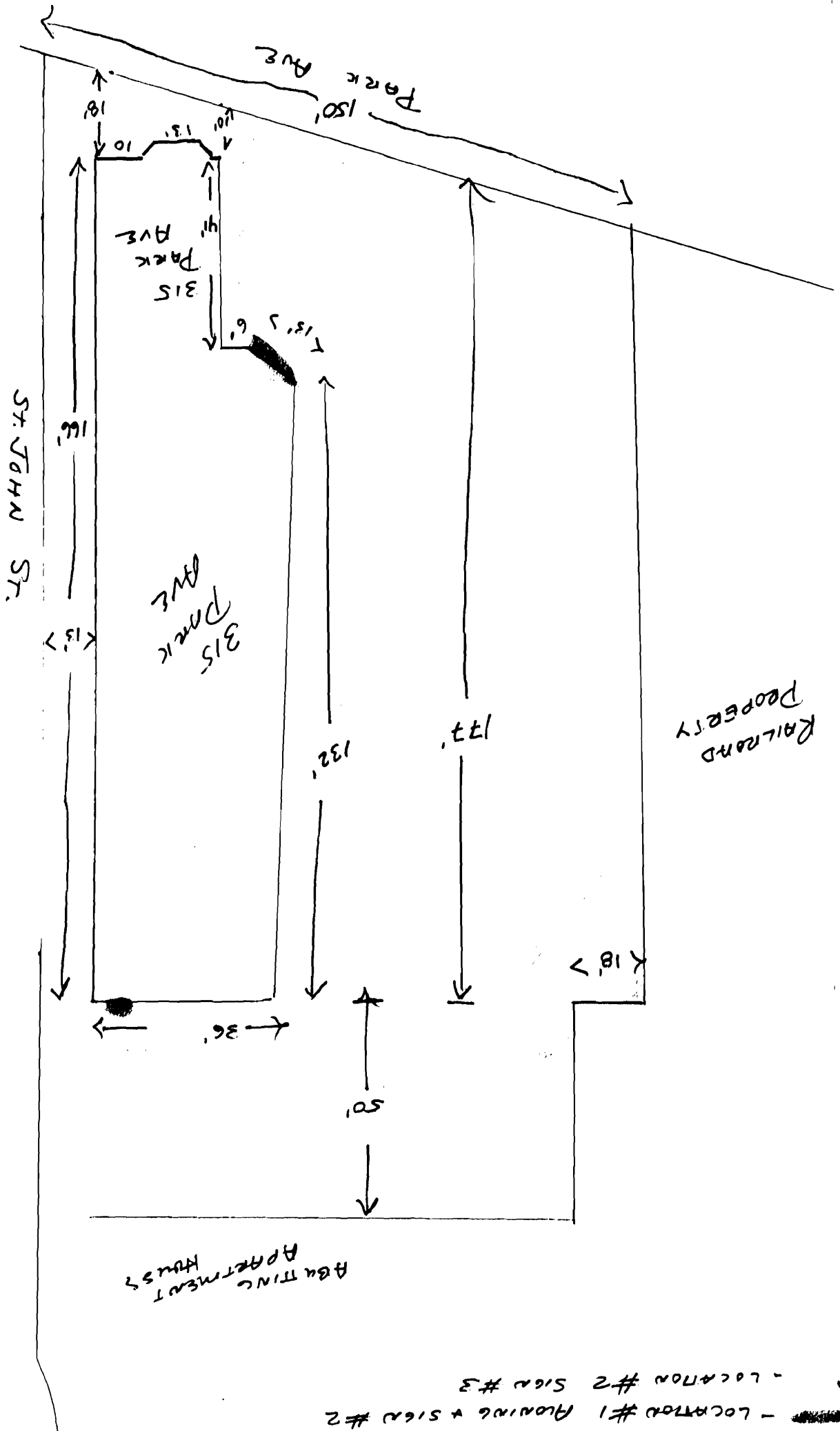

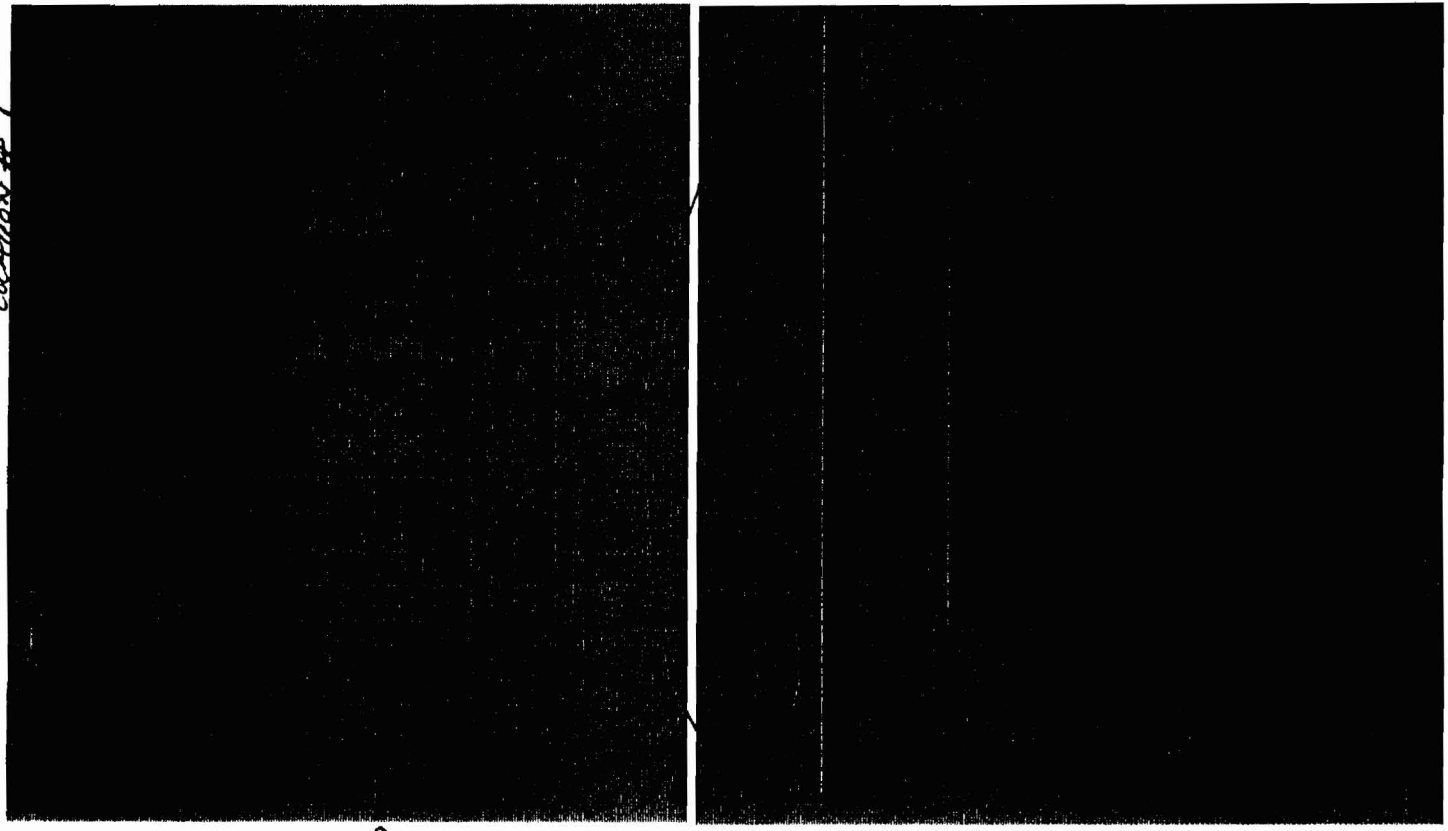

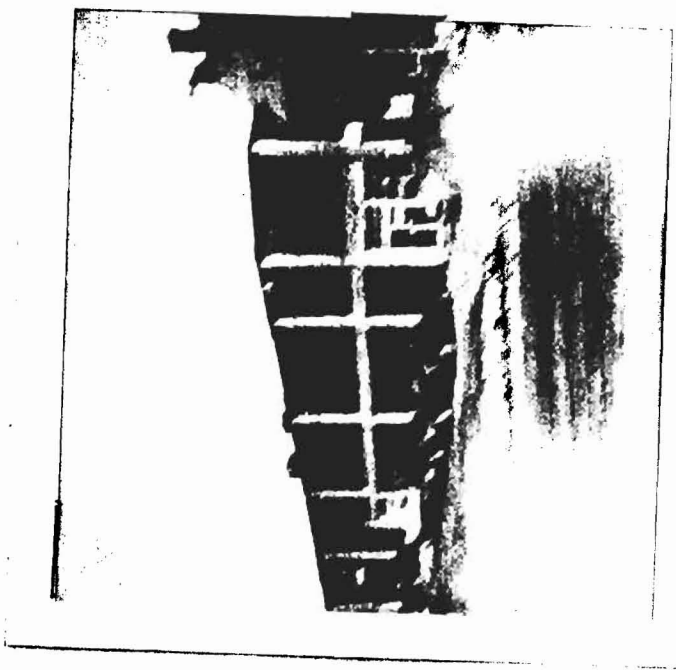
SIGNAGE AT CUSTOMER ENTRY LOCATION #1

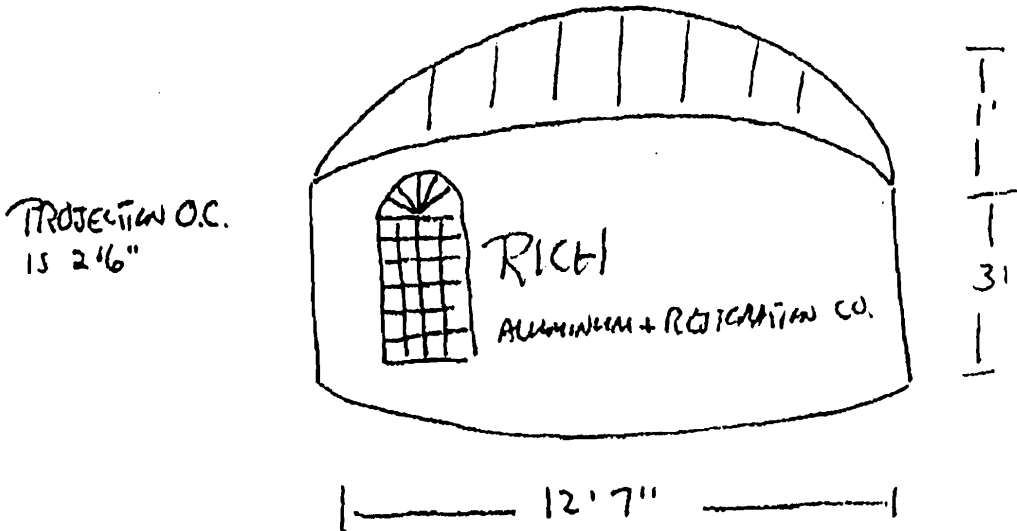

No cancellations will be accepted after work has started, or on special order merchandise. Delivery dates shown are approximate unless otherwise stated.

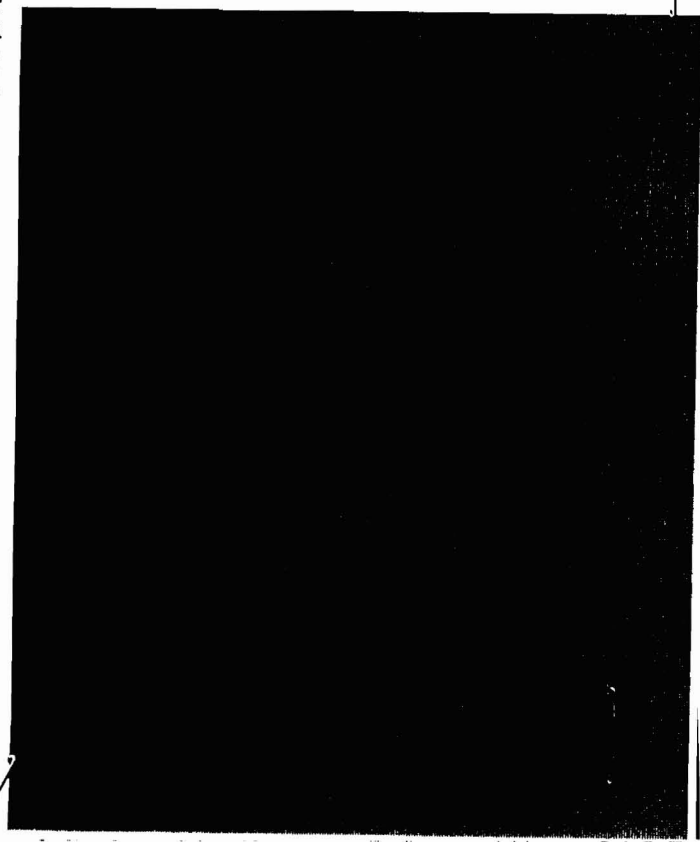

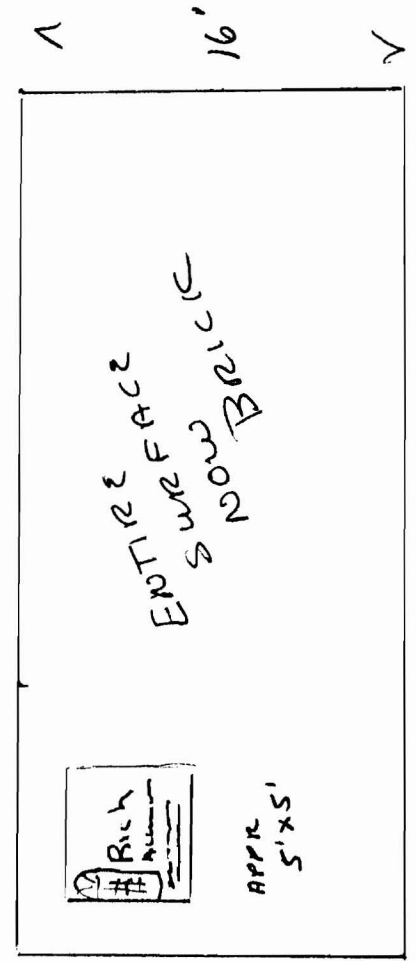
SIGNAGE @ REAR FACADE
