



EXHIBIT A
(Deed)

A certain lot or parcel of land with the buildings thereon, and appurtenances thereto, situated in City of Portland, County of Cumberland and State of Maine, on the easterly side of St. John Street and bounded and described as follows:

Beginning at a stake on the easterly side of St. John Street, which is the southerly corner of a lot of land conveyed by Anatole C. Carles to Margaret E. Brooks on May 6, 1912 and recorded in the Cumberland County Registry of Deeds in Book 891, Page 435;

thence along St. John Street South $14\ 1/4^\circ$ East Fifty-six (56) feet, more or less, to a post;

thence North $75\ 3/4^\circ$ East to the westerly side line of Douglas Farm so called, One Hundred and Sixteen (116) feet, more or less;

thence North $14\ 1/4^\circ$ West Fifty-six (56) feet, more or less, to a point, being the corner of the lot of land conveyed by Anatole C. Carles to the said Margaret E. Brooks by the aforesaid deed of May 6, 1912;

thence South $75\ 3/4^\circ$ West, One Hundred Sixteen (116) feet, more or less, to the point of beginning.
