A certain lot or parcel of land with the buildings thereon situated in said City of Portland on the westerly side of Vaughn Street and being further bounded and described as follows:

beginning on the westerly side of Vaughn Street at the northeasterly corner of land conveyed by J. B. Brown & Sons to Walter G. Davis by Deed dated December 20, 1910, and recorded in the Cumberland County Registry of Deeds in Book 869, Page 108; thence running westerly along the northerly line of said Davis land 134.53 feet to a twenty (20) foot wide passageway; thence running northerly along said passageway 95 feet to the southwesterly corner of land conveyed by Helen C. Donahue to Robert Treat Whitehouse by Deed dated July 23, 1918, and recorded in said Registry of Deeds in Book 1011, Page 148; thence running easterly by the southerly line of said Whitehouse land 134.53 feet to the westerly line of said Vaughn Street; thence running southerly by the westerly line of said Vaughn Street 95 feet to the point of beginning.

Also hereby conveying the right in common with others to use said passageway. This conveyance is made on the condition that no building shall be erected within twenty (20) feet of the westerly line of said Vaughn Street.
