Thank you for the additional information and I did meet with my colleagues yesterday to determine how to advise you regarding the permitting for the new and replacement signs at Mercy Fore River.

PROCESS

As advised before you will need to make two applications, both would be via the Portland Citizens Self Service (CSS) Portal (I sent you the link previously) but in two separate applications (see detailed advice below for content of the applications):

- Application for a <u>Sign Permit</u> for the building mounted signs, the large monument sign at the entrance, and a few of those signs that announce the hospital from the public highway. The intake on this is through the Permitting and Inspections Department and the fee will be determined by them based on the application.
- Application for a Site Plan Amendment to the Wayfinding Plan that was approved as part of the original Mercy development in 2006. This application would be to the Department of Planning an Urban Development with a fee of \$250. This would include the "directional" signs that you are changing from post-mounted to "monument". As noted previously, some of these appear to create safety issues because they block visibility of both cars and pedestrians and may not be in compliance with our standard (for signs on both private and public property) that includes the requirement that directional signage shall not adversely affect visibility at intersections or access drives on or off site.

CONTENT

Sign Permit:

For the sign permit, we will need:

- Overall site plan showing the location of each sign (as listed below) color keyed as to existing removed; existing remaining; proposed
- Indication of the dimensions, font, color, lighting, and mounting of each new sign

- One elevation showing existing signs- full elevation of that side of the building
- Matching full building elevation showing new signs and existing signs to remain in the correct size and placement (ie the final signage on that entire elevation)
- Dimensions, font, color, lighting, mounting of existing signs to remain
