I'm just inquiring about an administrative authorization for the above address (BP# 2016-01751). Unfortunately this contractor went well beyond the initial scope/description of work and tore the house down to the deck (first floor). After re-reviewing and several discussions with Ann and Chris, it appears that he has satisfied the process for applying for an "Additions permit". The demo checklist was completed after the fact and based on the circumstances looks to have again satisfied the requirements. Water, Natural Gas, and Sewer are still all connected to the property because this was not a complete demo (foundation and first floor deck flooring are still in-tact). This is a case where it was a simple building permit issued for renovations and became complicated by

the contractor's choice.
