- 1) The existing footprint of the building is not legal and not in compliance with zoning. The rear deck was expanded from 10' x 12' (#83-0195) to 10' x 20' without a permit and a front open deck was added without a permit. The owner has thirty days from the date of the letter, September 25, 2014, to bring the property into compliance.
- 2) This permit is being issued to permit the spiral staircase (already built) and the roof top deck.
- 3) This property shall remain a single family dwelling. Any change of use shall require a separate permit application for review and approval.

- 1) Separate permits are required for any electrical, plumbing, sprinkler, fire alarm, HVAC systems, heating appliances, including pellet/wood stoves, commercial hood exhaust systems and fuel tanks. Separate plans may need to be submitted for approval as a part of this process.
- 2) Hardwired photoelectric interconnected battery backup smoke detectors shall be installed in all bedrooms, protecting the bedrooms, and on every level.
  - The same is required for existing buildings, where permanent wiring is feasible; or at the very least battery operated smoke detectors are required. Verification of this will be upon inspection.
- 3) Carbon Monoxide (CO) alarms shall be installed in each area within or giving access to bedrooms. That detection must be powered by the electrical service (plug-in or hardwired) in the building and battery.
- 4) A letter from a registered design professional shall be submitted to this office regarding the second floor deck attachment compliance for all live, dead, and lateral load requirements of the IRC.
- 5) The spiral stairs shall be installed per the code specifications in IRC Sec. R311.7.9 or IBC Sec. 1009.9
- 6) Open risers are permitted, provided that the opening between treads does not permit the passage of a 4" diameter sphere.
- 7) When over 30" above a floor or grade, guardrail openings shall be less than 4", stairail openings shall be less than 4-3/8", and at the open side of a stair, less than 6" is allowed at the triangle of the tread/riser at the bottom rail.
