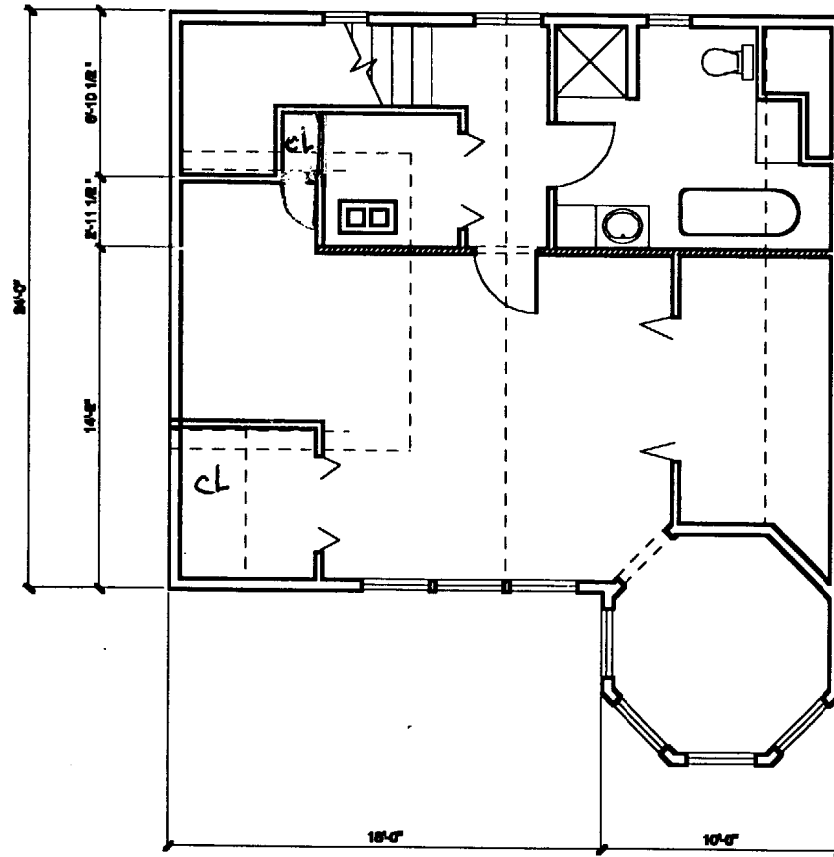


20 front elevation
