 To grant relief from section 14-145.11(c)(1) of the Land Use Zoning Ordinance which requires a minimum front setback of twenty-five (25) feet instead of the zero (0) feet shown, section 14-145.11(c)(2) of the Land Use Zoning Ordinance which requires a minimum rear setback of twenty-five (25) feet instead of the zero (0) feet shown, and from section 14-145.11(c)(3) of the Land Use Zoning Ordinance which requires a minimum side setback of twenty (20) feet instead of the two (2) feet shown for an existing boardwalk for handicap accessibility.
