In order for there to be volume there would need to be fixed exterior walls, so leaving that portion of the structure wide open would not be a volume expansion. The Department's position on the use of traditional common lattice is that it also would not create volume, but some municipalities apply the standard more restrictively and do count it as volume so please consult with the municipal officials regarding use of lattice or similar.
