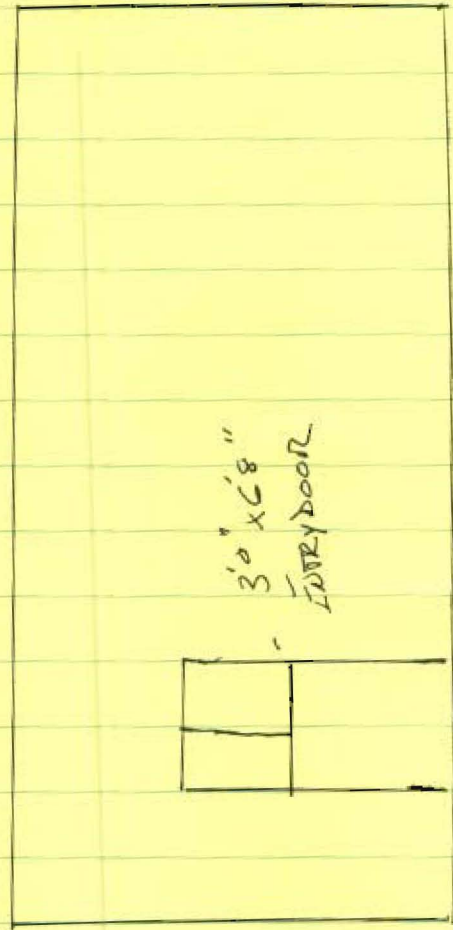
West Elevation

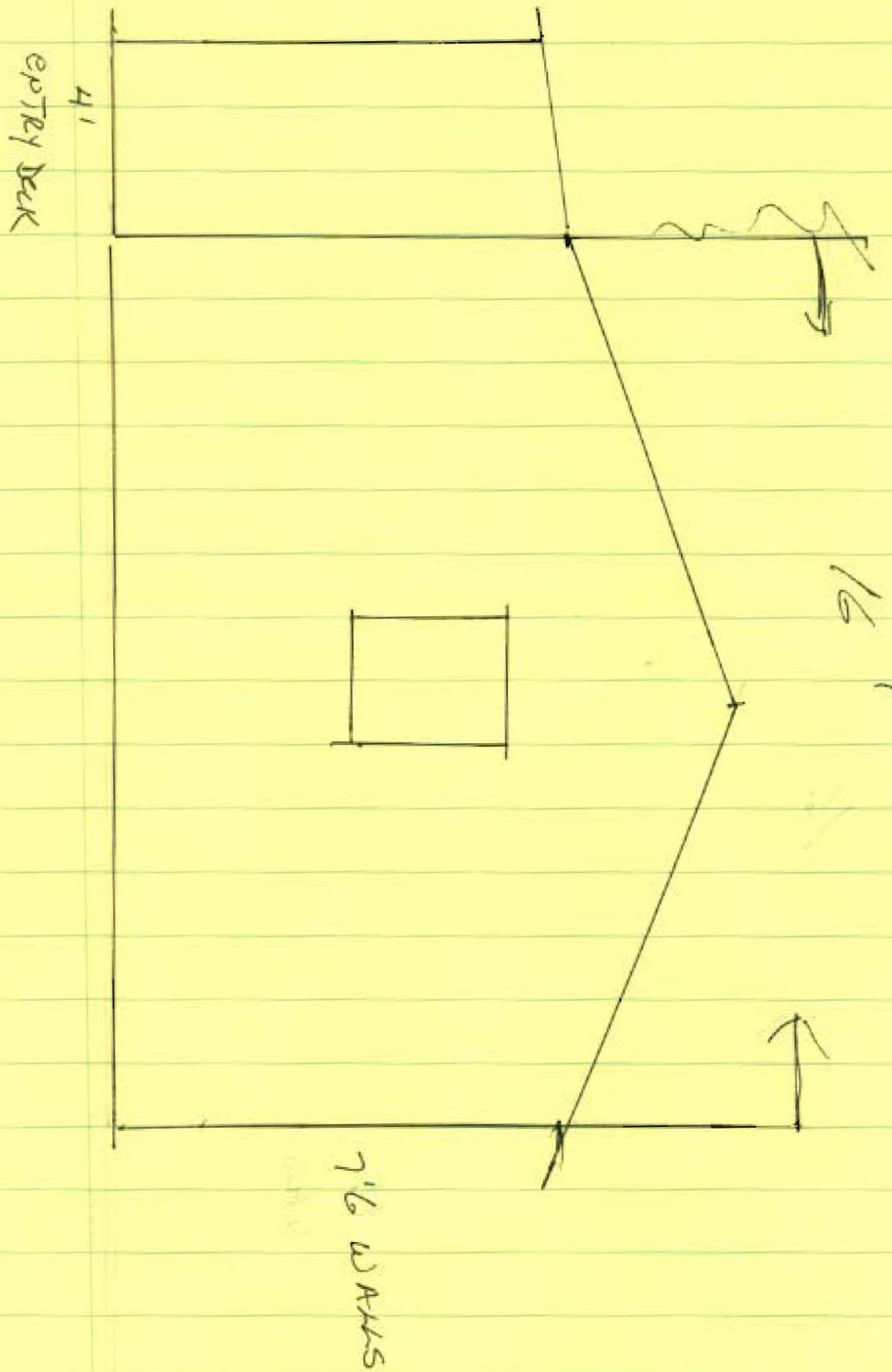
East Elevation



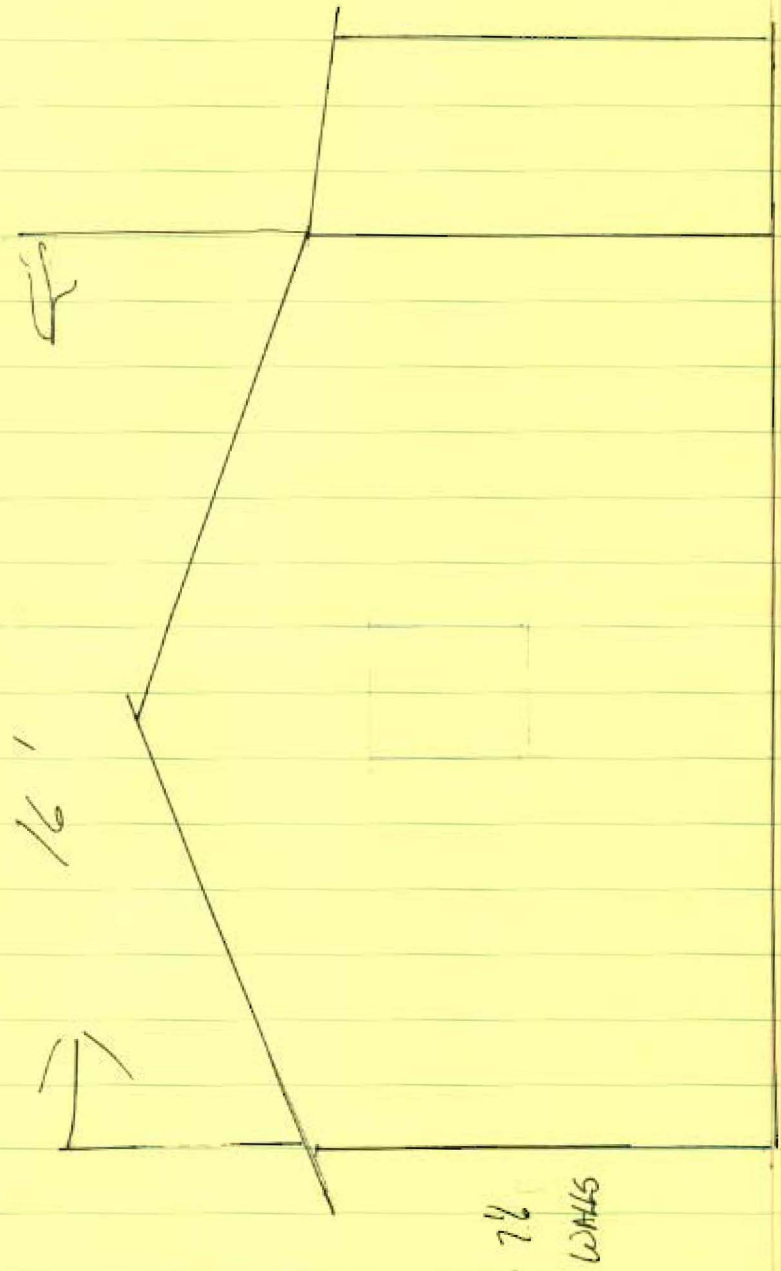

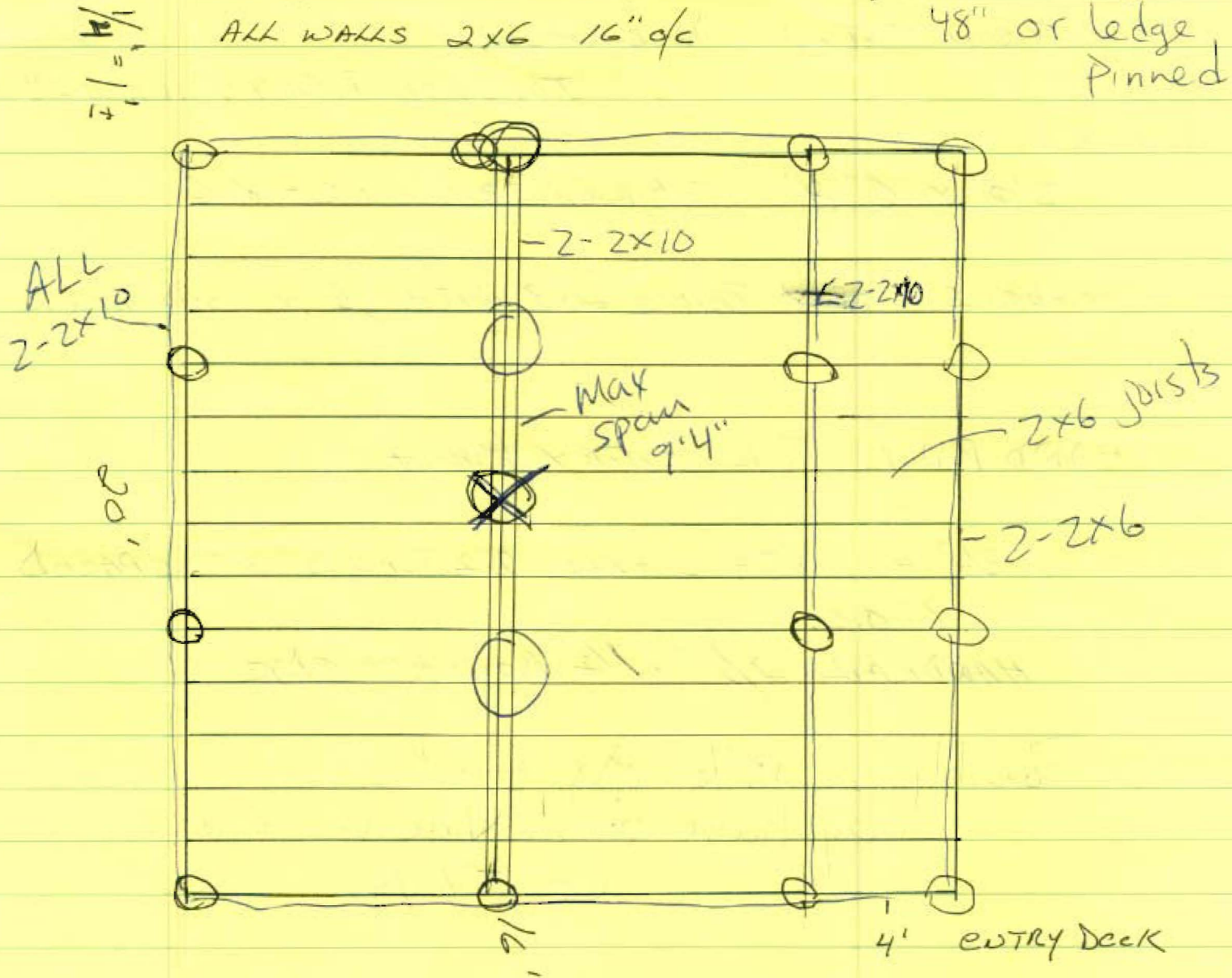
