A certain lot or parcel of land with the buildings thereon situated on Peaks Island in the City of Portland, County of Cumberland and State of Maine, on the westerly side of Island Avenue and the southerly side of Ocean Street, being Lot #3 on a recorded plan of Sterling Farms and containing approximately 3,800.00 square feet, and being more particularly described in a deed from William B. Shaw to John F. Proctor dated June 11, 1903 and recorded in Cumberland County Registry of Deeds in Book 1158, Page 191, to which reference is made for a description of the premises.

Said parcel being more particularly bounded and described as follows:

A certain lot or parcel of land located on the northwesterly side of Island Avenue on Peaks Island, Portland, County of Cumberland, State of Maine, being more particularly bounded and described as follows: Beginning at a point at the northwesterly corner of Baxter Scott's land and thence south sixty-two degrees east (S 62° E) eighty-three feet (83') to the northwesterly side of Island Avenue, thence south forty-four degrees west (S 44° W) fifty-one feet ten inches (51'10") by said Avenue, thence north sixty-two degrees west (N 62° W) sixty-nine feet (69') to land of said Baxter Scott, thence north twenty-eight degrees east (N 28° E) fifty feet (50') by land of said Scott to the point of beginning.
