Please contact the City electrical inspectors with any questions.</li> <li>2) Must be installed per the manufacturer's installation instructions</li> <li>3) Separate permits are required for any electrical, plumbing, sprinkler, fire alarm, HVAC systems, heating appliances, including pellet/wood stoves, commercial hood exhaust systems, fire suppression and fuel tanks. Separate plans may need to be submitted for approval as a part of this process.</li> <li>4) This permit is approved based upon information provided by the applicant or design professional. <b>Conditions:</b>		<ol style="list-style-type: none"> <li>1) Boiler and Fuel-fired heater rooms serving more than a single dwelling unit require 1 hour separation and sprinklers.</li> <li>2) Fuel-fired boilers shall be protected in accordance with NFPA 101, Life Safety Code.</li> <li>3) Installation shall comply with NFPA 90A, Standard for the Installation of Air-Conditioning and Ventilating Systems; NFPA 90B, Standard for the Installation of Warm Air Heating and Air Conditioning Systems; NFPA 91, Standard for Exhaust Systems for Air Conveying of Vapors, Gases, Mists, and Noncombustible Particulate Solids; NFPA 31, Standard for the Installation of Oil Burning Equipment; NFPA 211 Standard for Chimneys, Fireplaces, Vents, and Solid Fuel Burning Appliances; NFPA 54, National Fuel Gas Code; NFPA 70 National Electrical Code; and all manufacturer's published recommendations.</li> <li>4) All means of egress to remain accessible at all times.</li> <li>5) All construction shall comply with 2009 NFPA 1, Fire Code.
