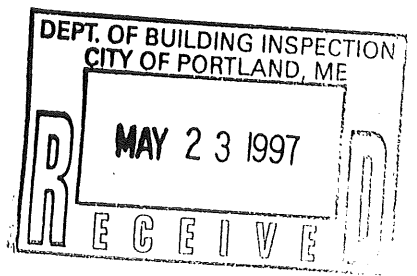

It has come to the attention of our Code Enforcement Office that it appears that you are operating a junkyard business at the above location of 398-400 St. John Street. Merle Leary, the Code Enforcement Officer in this area is sending you a clean-up notice for all the exterior debris which is contributing toward rodent harborage.

As far as zoning, you are located in a R-6 residential zone which does not allow a junkyard business. Any such use must cease immediately, and the area cleaned up as ordered. It will be necessary to see that this use is discontinued within 30 days. If no such change is seen, this matter shall be turned over to our legal counsel for further legal action.

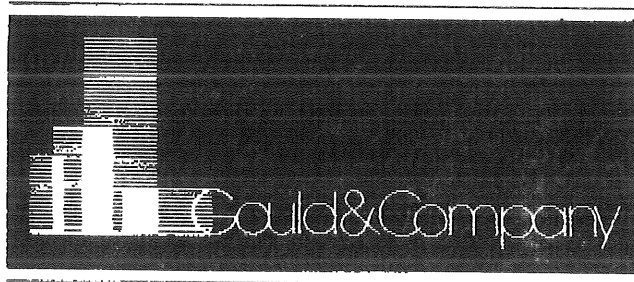

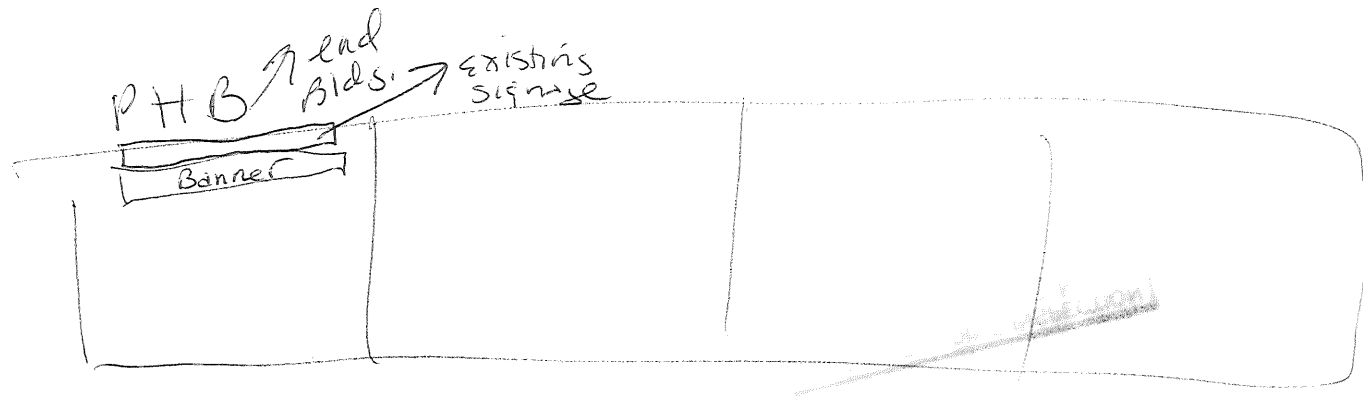

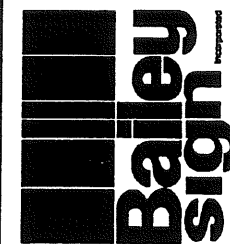
