

lamwriting in response to our recent conversations regarding fire retardant certificates for awning permits.

After speaking with you I took the liberty of calling other manufacturers/fabricators and have found the following information to be of great interest. A fire retardant certificate will not be produced until the goods are shipped to the manufacturer/fabricator for production. This does create a problem for a permit applicant (**Bradford Rug**) requiring fire retardant certification. This action to start manufacturing by purchasing could in due hardship if the permit were not issued.

For this reason we would like to suggest a submittal as conditions of approval: that product documentation accompany the application for which a certificate is required. Thus, the certificate for the jobs be presented prior to installation. This should not slow the permitting process and would insure that the proper documents are on file for future reference.
