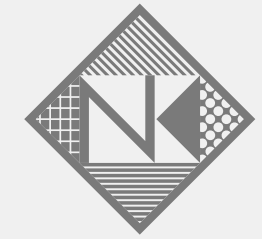




D INTERNALLY ILLUMINATED WALL LETTERS - WEST ELEVATION

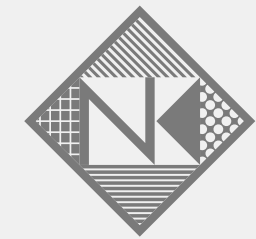

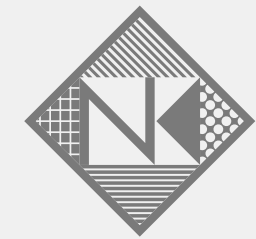
