REFLECTED CEILING PLAN NOTES

1. RE RFS FOR CEILING HEIGHTS, TYPES, AND FINISHES, U.N.O.
2. FIRE SPRINKLERS SHALL BE LOCATED IN ALIGNMENT WITH OTHER CEILING ITEMS.
3. FIRE SPRINKLERS SHALL BE CENTERED IN CEILING TILE WHERE APPLICABLE.
4. FIRE SPRINKLERS SHALL BE PLACED TO COORDINATE WITH LIGHT FIXTURE POSITIONS INDICATED.
5. FIRE SPRINKLERS ARE SHOWN FOR COORDINATION ONLY. ADDITIONAL SPRINKLERS MAY BE REQUIRED FOR CODE COMPLIANCE AS DETERMINED BY THE FIRE PROTECTION DESIGNER. SPRINKLERS MAY NOT BE SHOWN IN ALL AREAS WHERE REQUIRED. FIRE PROTECTION CONTRACTOR SHALL BE RESPONSIBLE FOR PROVIDING A COMPLETE AND FULLY CODE COMPLIANT SYSTEM, INCLUDING HEADS NOT INDICATED IN THIS DRAWING. RE: MECH.
7. EXCEPT WHERE INDICATED, CENTER CEILING GRIDS IN ROOMS. USE HALF TILES OR GREATER @ PERIMETERS AS POSSIBLE.
8. PROVIDE ACCESS PANELS AS REQUIRED IN GWB CEILINGS FOR ACCESS TO MECHANICAL VALVES/ CONTROLS. REFERENCE MECHANICAL.
