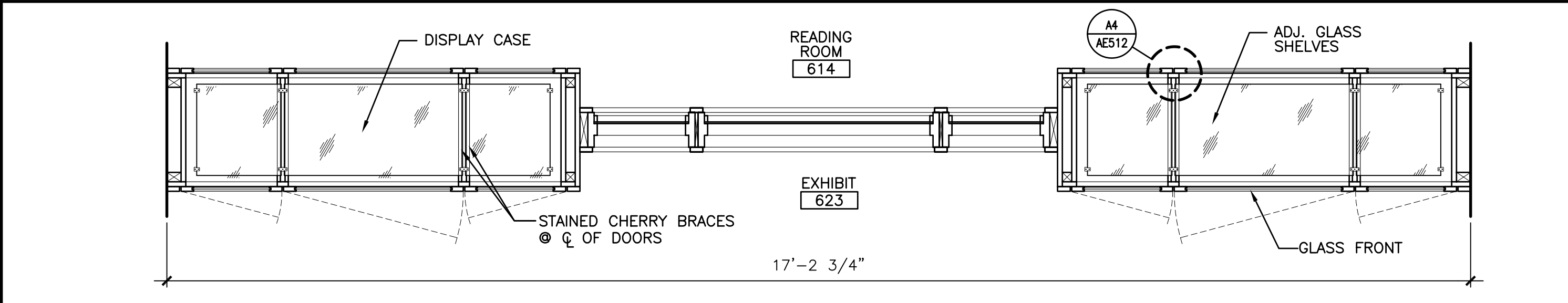

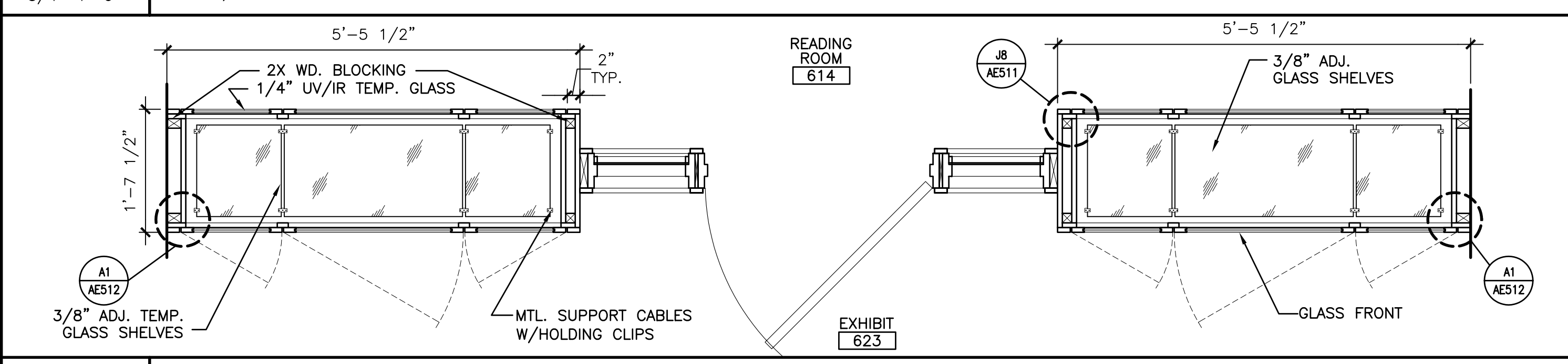

**CASEWORK NOTES:**

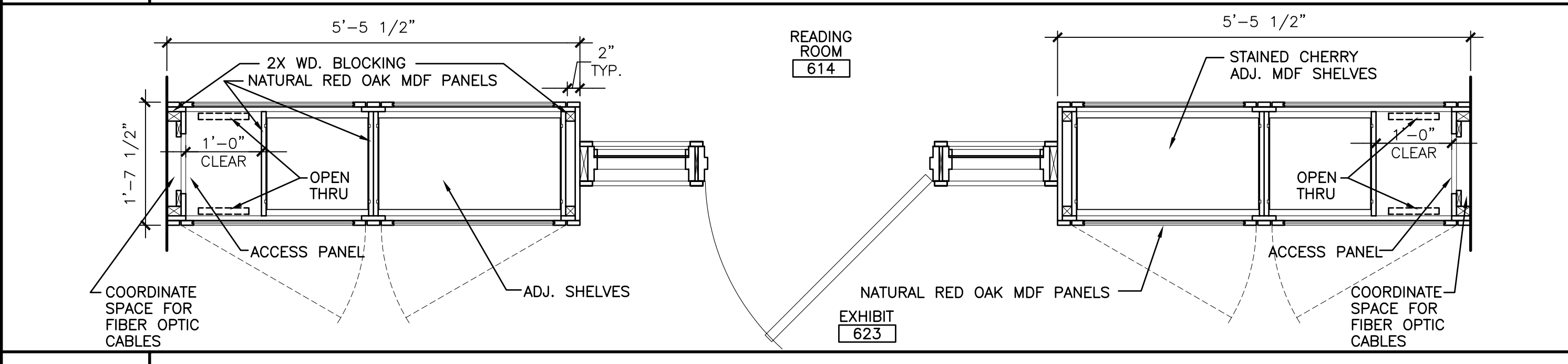
1. PROVIDE UPPER CABINET WHERE SHOWN IN ELEVATION ONLY.
2. PROVIDE CUTOUTS IN ALL CASEWORK AS REQUIRED FOR ELECTRICAL/ DATA WIRING. PROVIDE PLASTIC GROMETS @ ALL VISIBLE CUTOUTS IN CASEWORK.
3. PROVIDE A 1 1/2" WOOD FILLER ON CASEWORK THAT IS ADJACENT TO OR BETWEEN WALLS U.N.O.
4. ADD 1 1/2" FILLER ON CASEWORK WHERE TWO CABINETS JOIN @ AN INSIDE CORNER U.N.O.
5. ALL EXPOSED CABINET END PANELS TO BE FINISHED TO MATCH CABINETS AS SPECIFIED, U.N.O.
6. CUSTOM MILLWORK IS TO BE BUILT AS DRAW AND ALL DIMENSIONS ARE TO BE FIELD VERIFIED BEFORE CONSTRUCTION BEGINS. NOTIFY THE ARCHITECT OF ANY DISCREPANCIES IN WRITING PRIOR TO PROCEEDING WITH THE WORK.

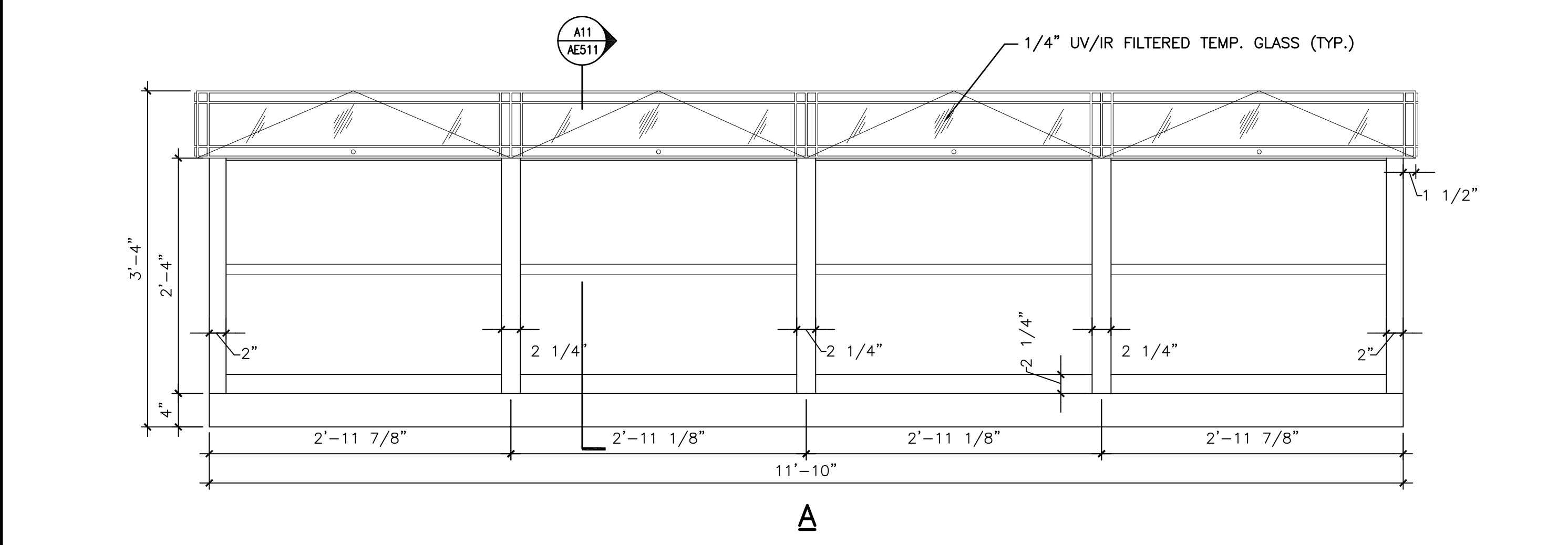

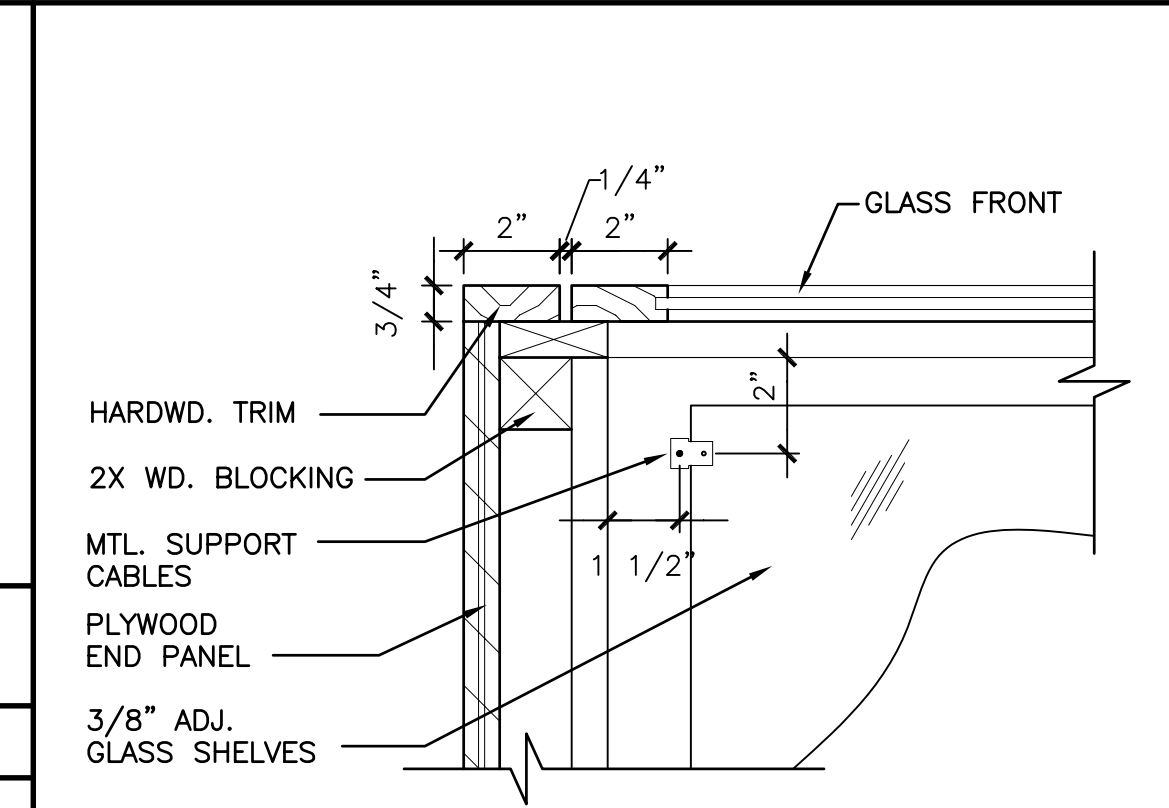
**J1 SECTION**

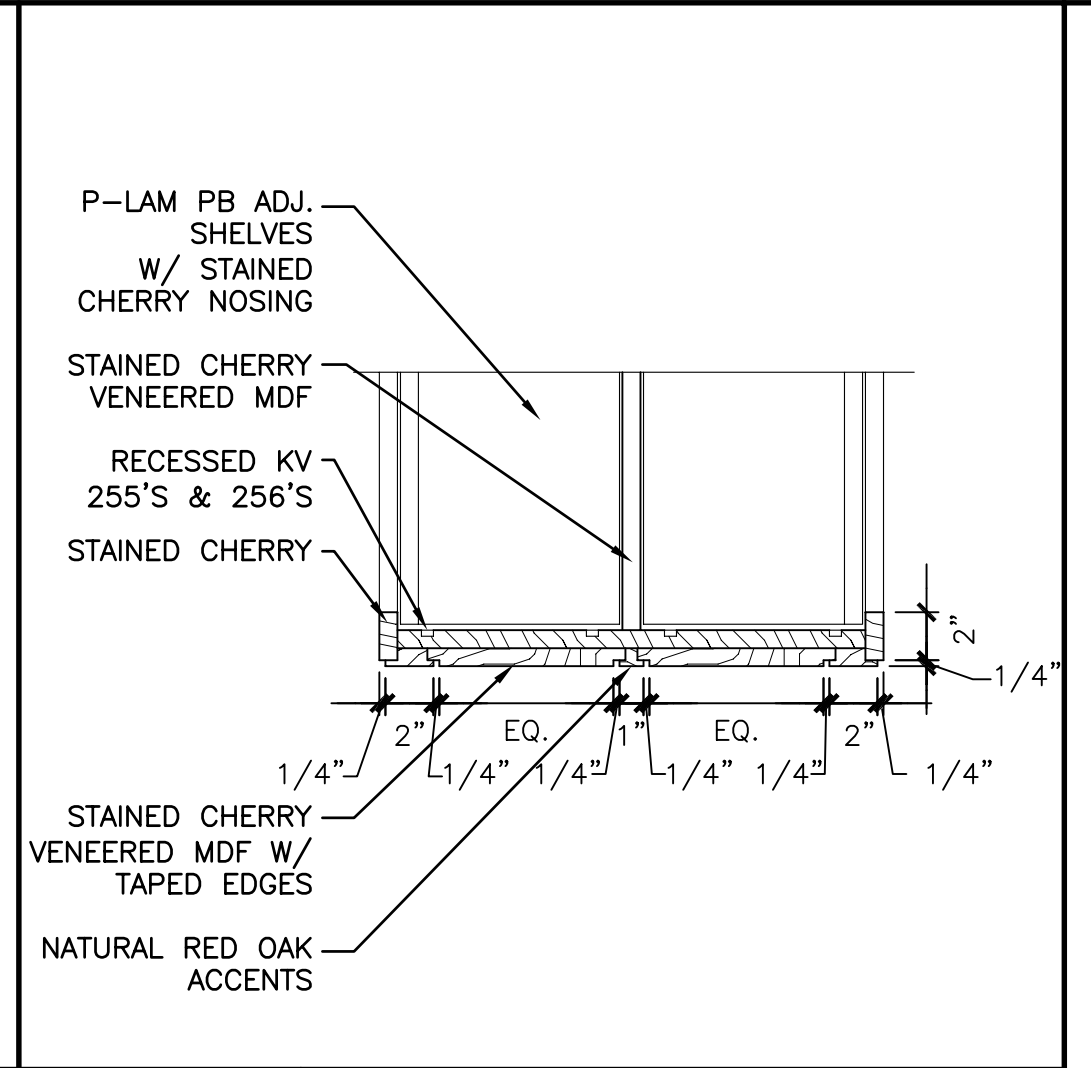
**E1 SECTION**

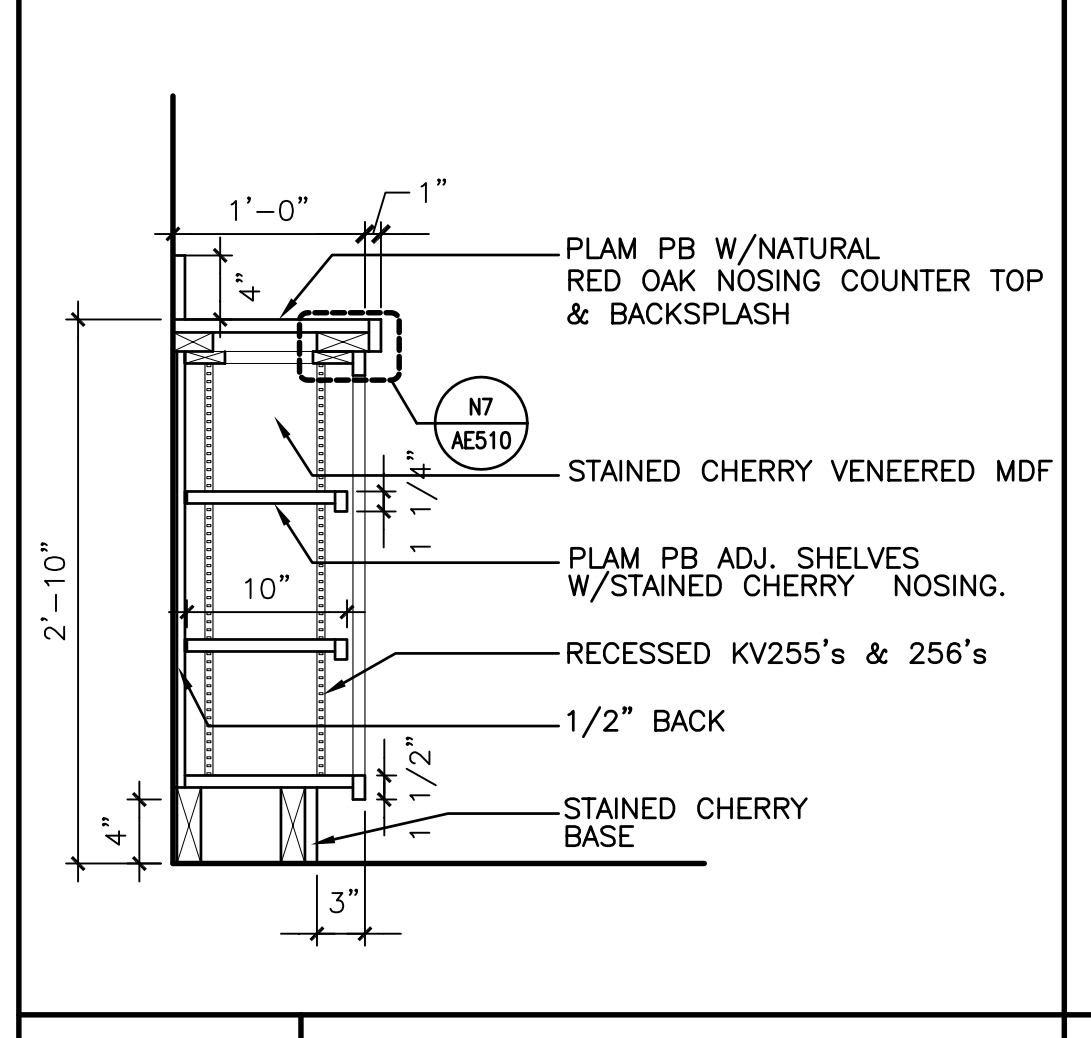
**A1 ELEVATION**

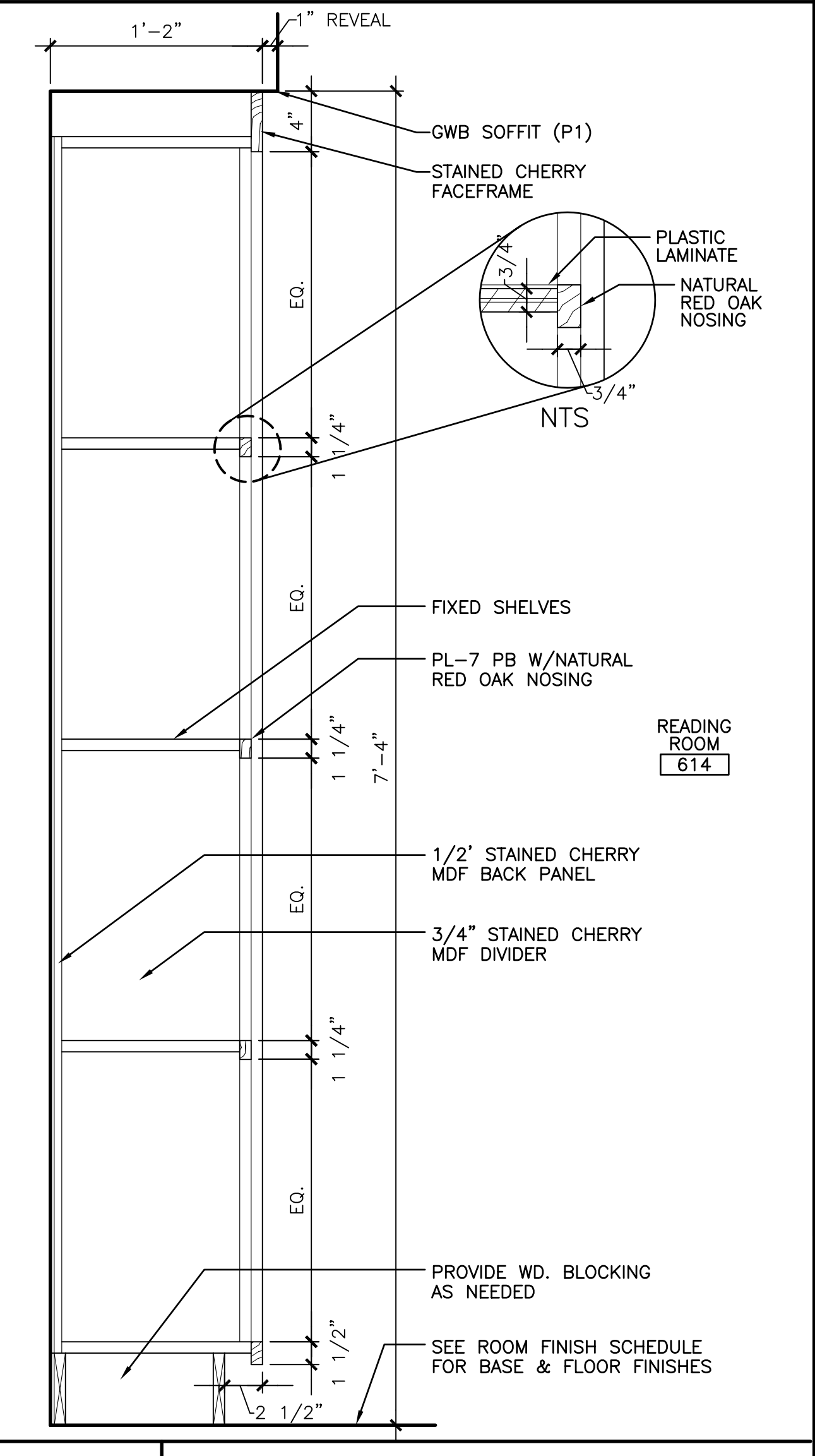
**J8 DETAIL**

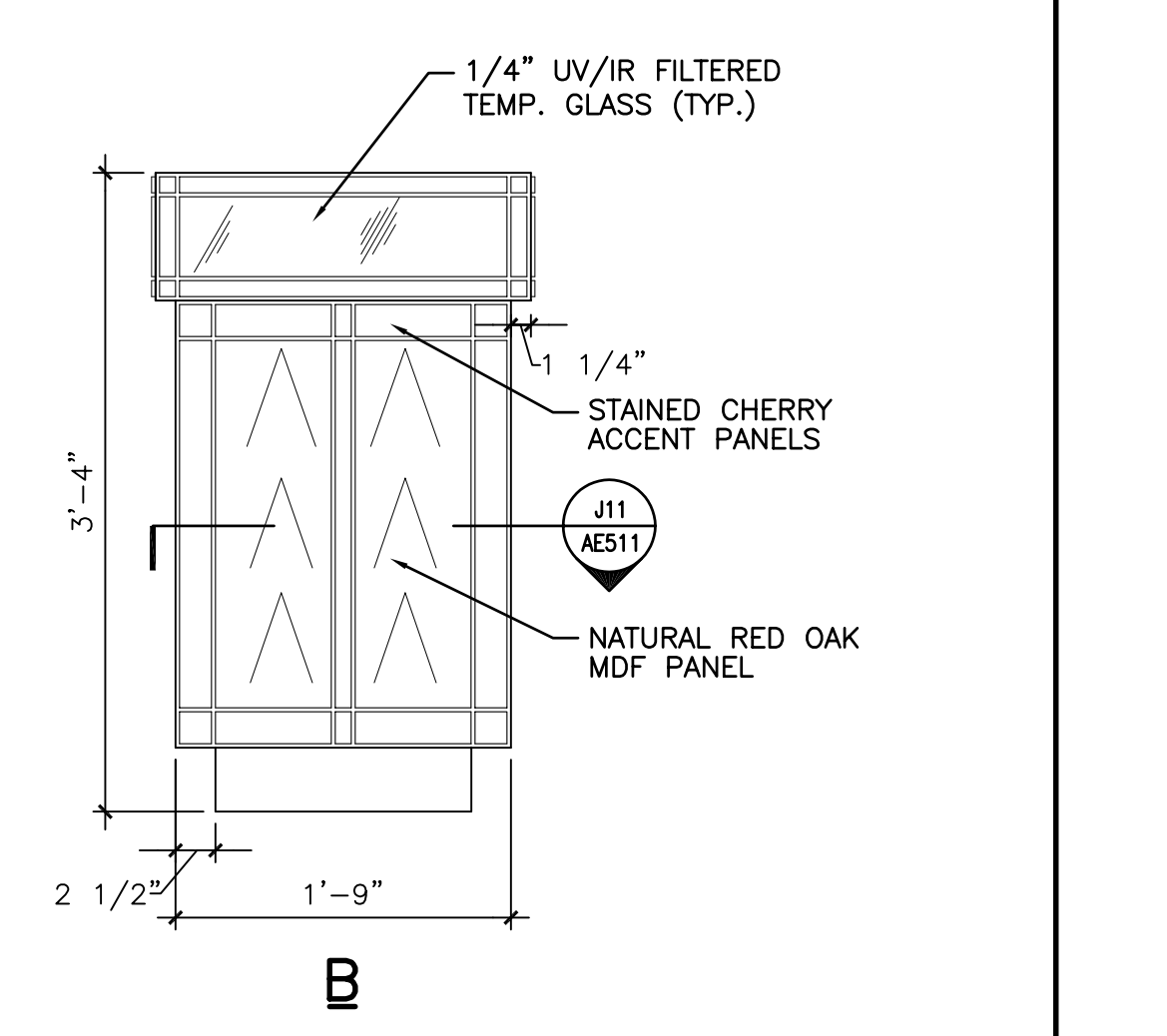

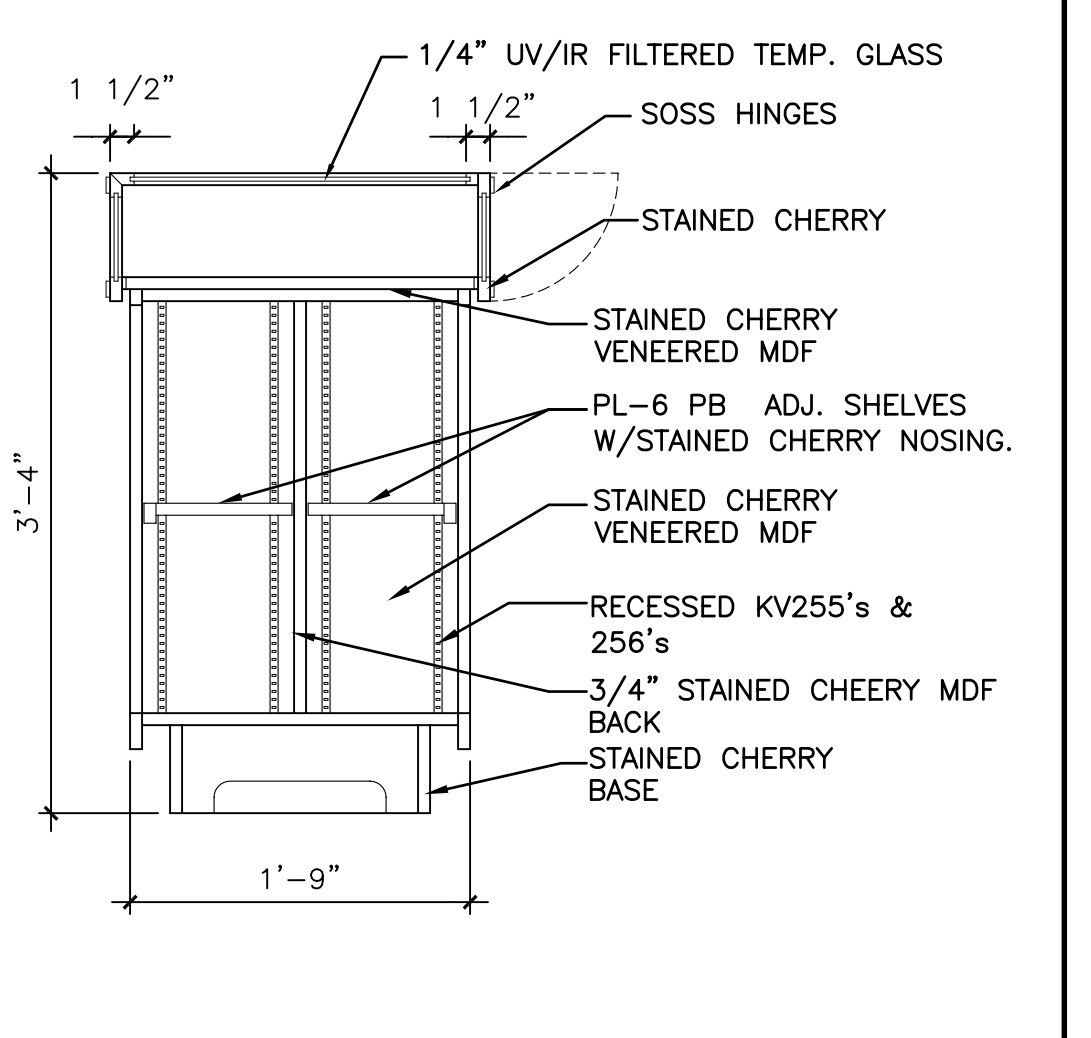

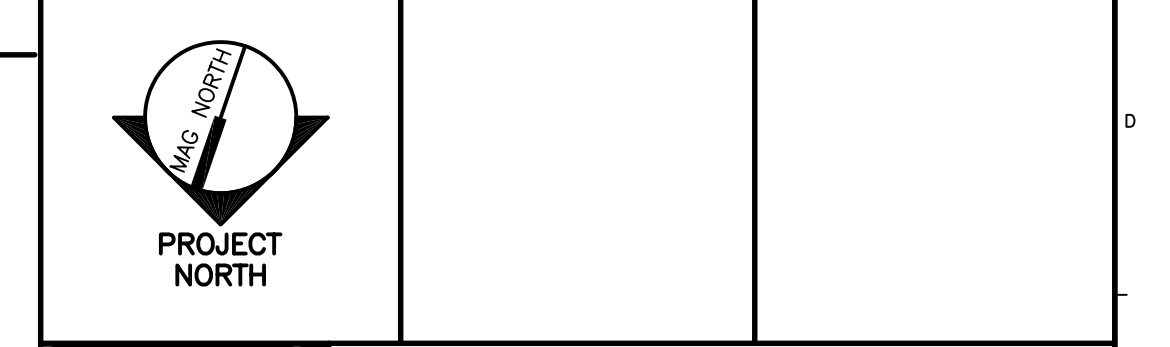
