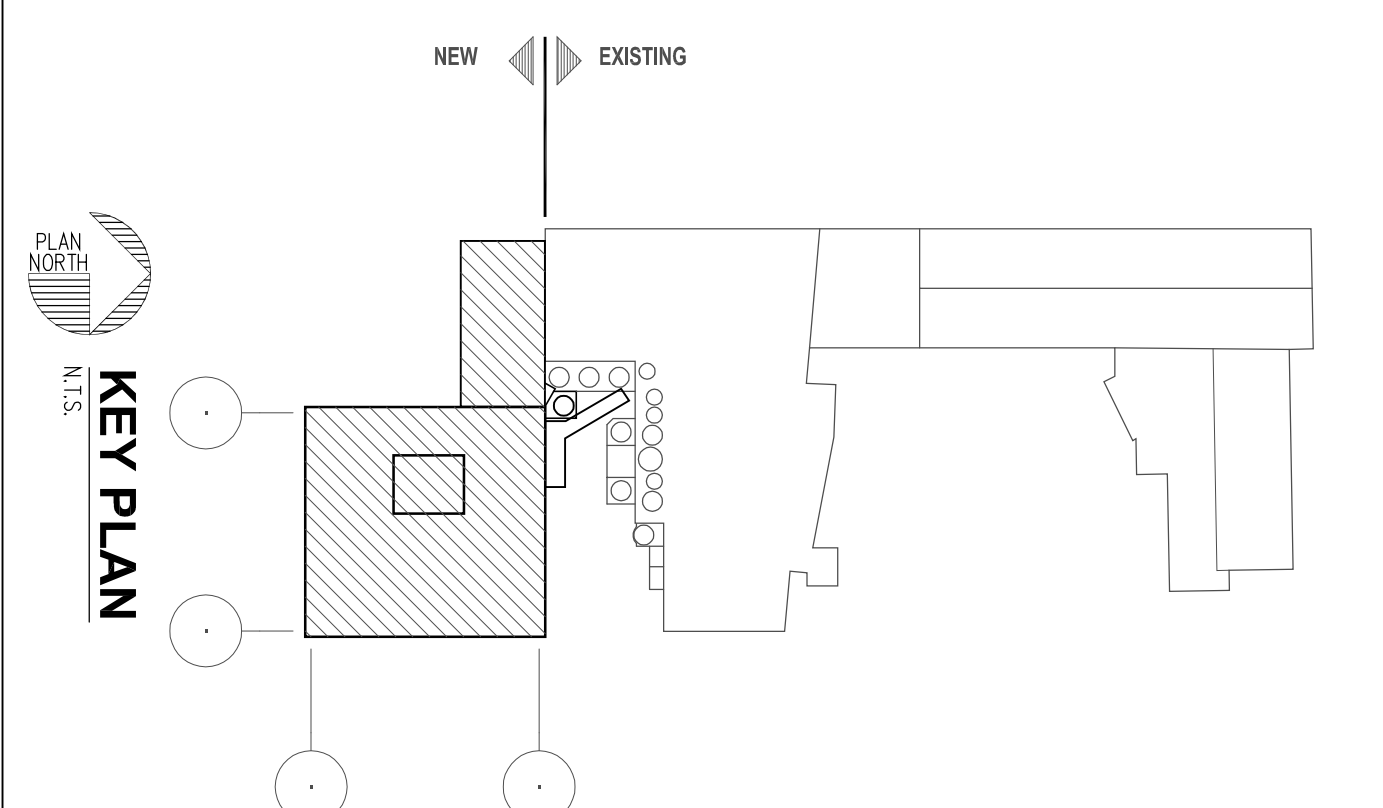
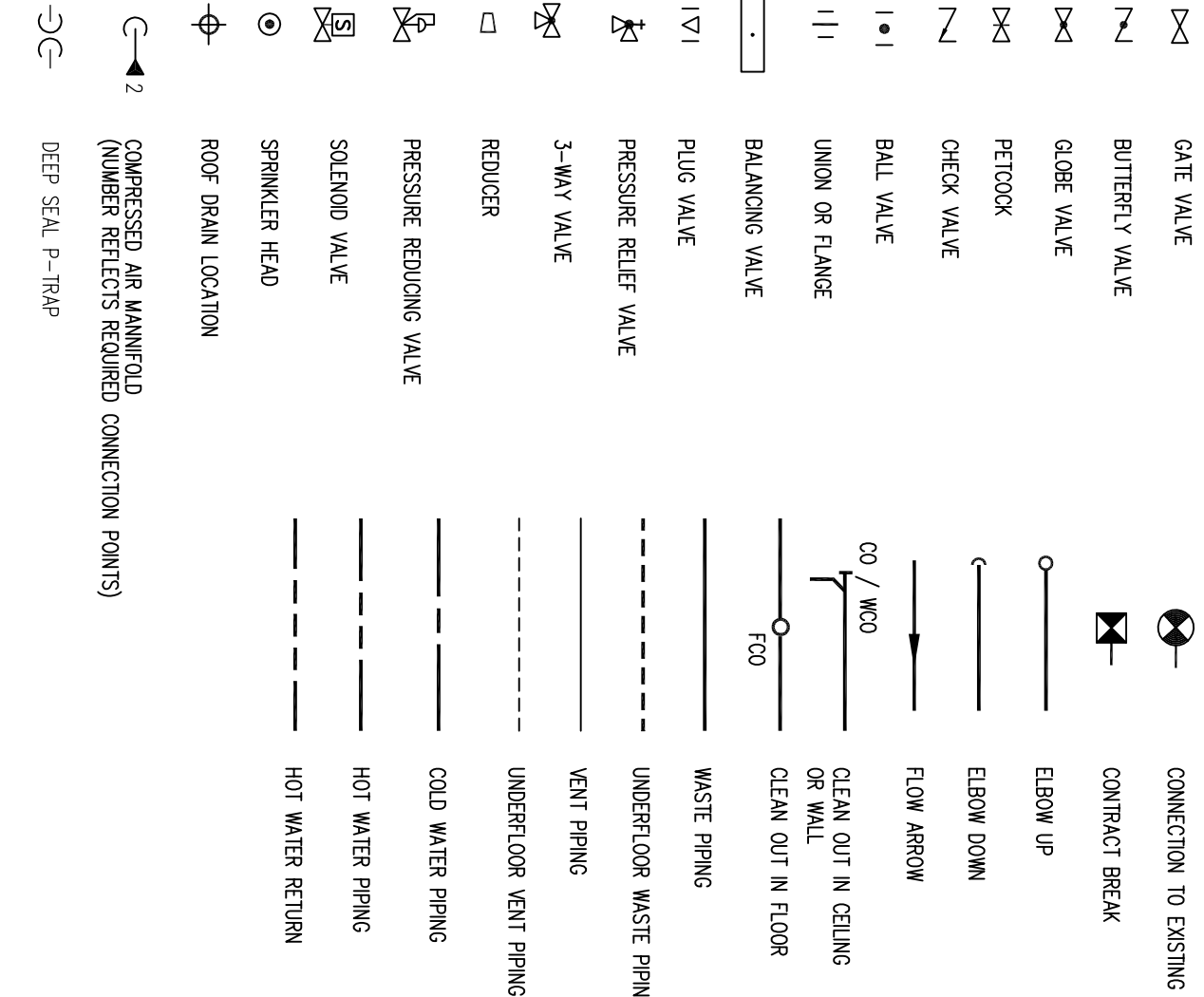
GENERAL PLUMBING NOTES:
