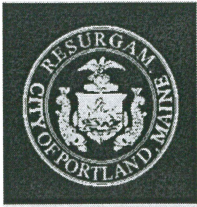

- Annunciator details
- Operations matrix

- Battery and voltage calculations
- Equipment data sheets
- A city electrical permit has been pulled

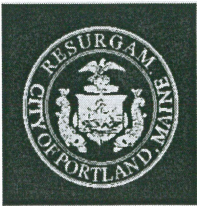
