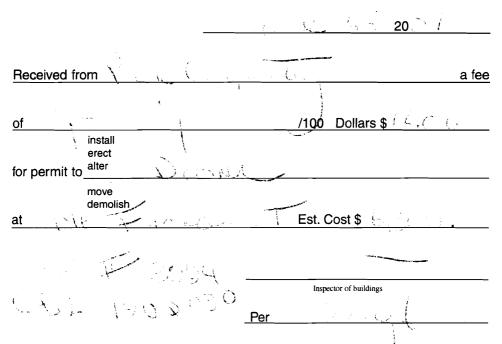


REAR ELEVATION SCALE 4" = 1'-0" MCCRACKING T.
