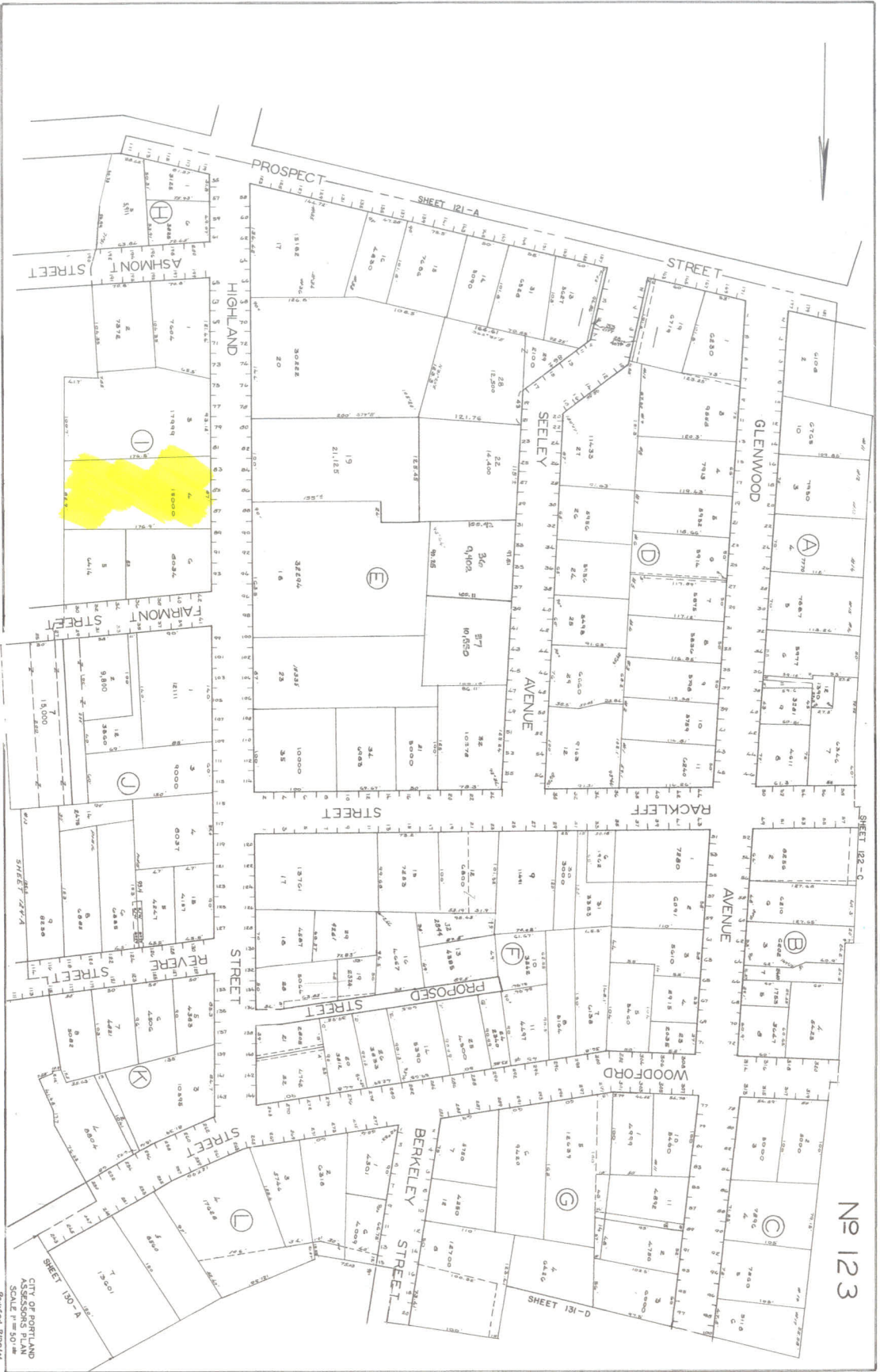

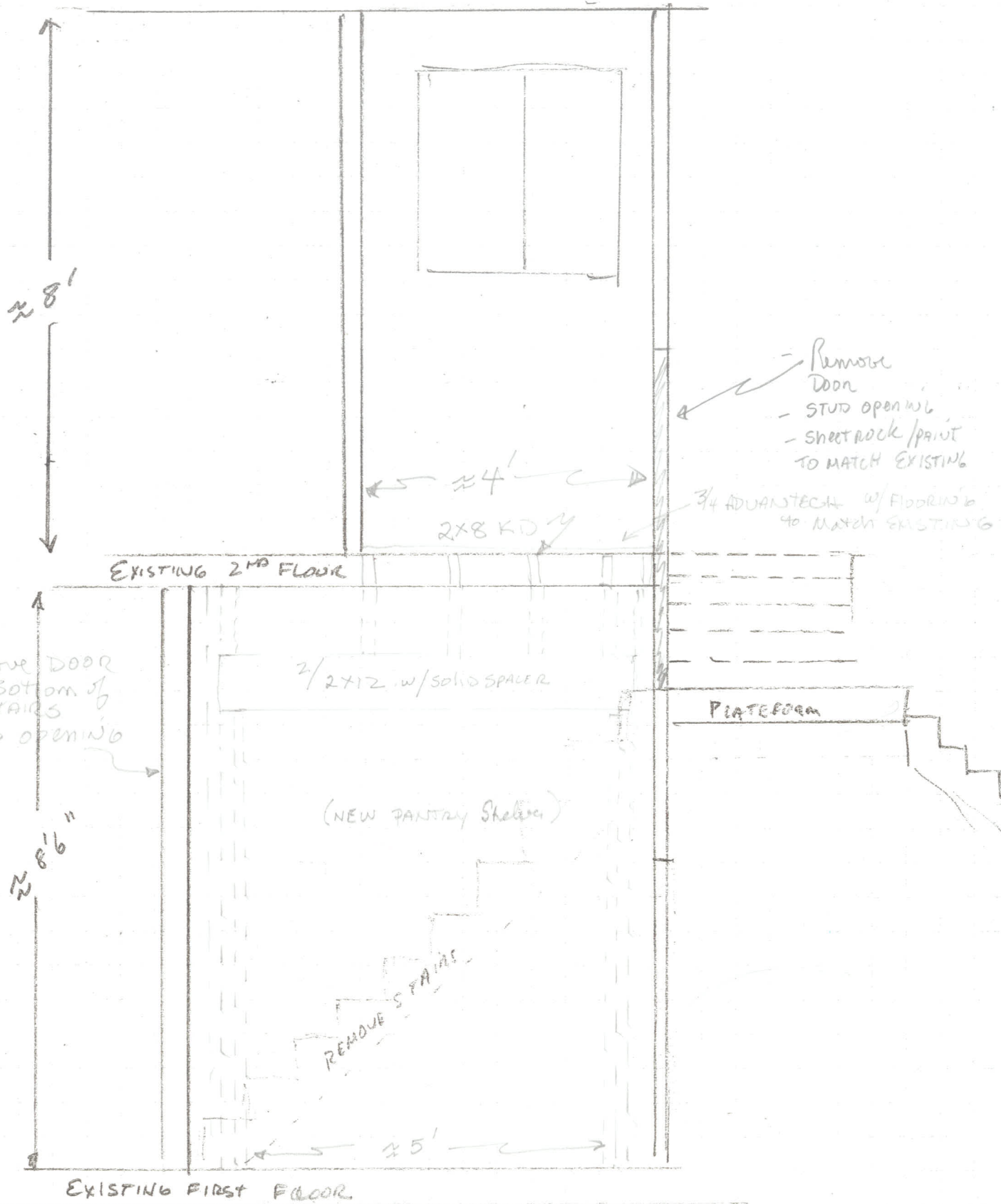

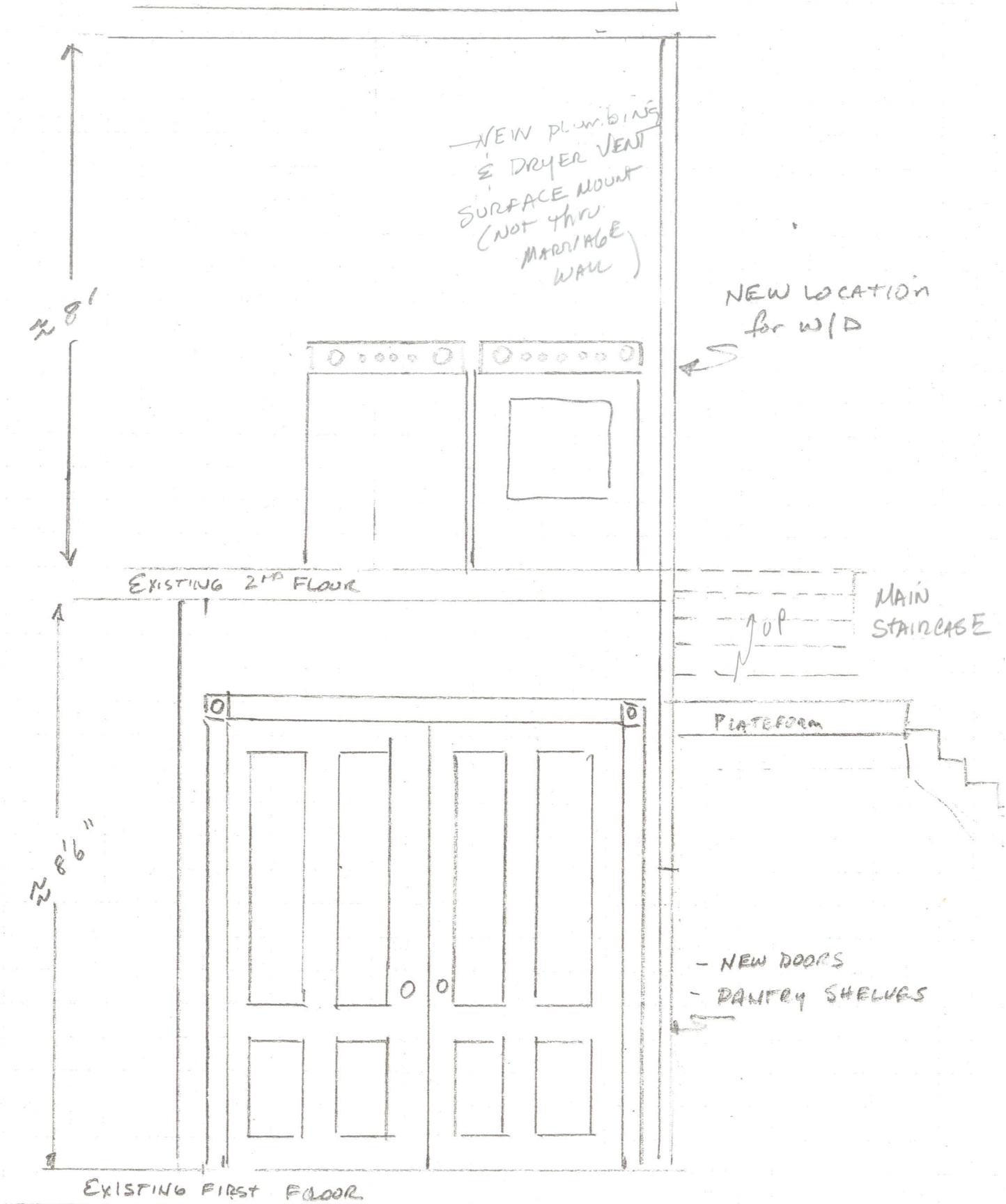


CITY OF PORTLAND
