Appointments must be requested 48 to 72 hours in advance of the required inspection. The inspection date will need to be confirmed by this office.

- **Permits expire in 6 months. If the project is not started or ceases for 6 months.**
- **If the inspection requirements are not followed as stated below additional fees may be incurred due to the issuance of a "Stop Work Order" and subsequent release to continue.**

It is approving interior work only. 2) Separate permits shall be required for future decks, sheds, pools, and/or garages. 3) Separate review and approval shall be required for alterations to the curb cut and driveway expansion. 4) This property shall remain a single family dwelling. Any change of use shall require a separate permit application for review and approval. 5) Separate permits are required for any electrical, plumbing, sprinkler, fire alarm, HVAC systems, heating appliances, including pellet/wood stoves, commercial hood exhaust systems, fire suppression and fuel tanks. Separate plans may need to be submitted for approval as a part of this process. 6) This permit is being approved on the basis of plans submitted. Any deviations shall require a separate approval before starting that work.
