Separate permits are required for any electrical: plumbing, sprinkler, fire alarm, commercial hood exhaust systems and fuel tanks. Separate plans may need to be submitted for approval as a part of this process. Maintain proper setback(s) from property lines/buildings and proper clearances from vertical openings when direct venting. M1804.2.5 Direct vent terminations.
