

MORTGAGE DEED
(Statutory Short Form)

RUTHERFORD** both of South Portland, County of Cumberland, State of Maine, for consideration paid, grant to **BEVERLY A. RUTHERFORD** of South Portland, County of Cumberland, State of Maine, whose mailing address is 166 Harriet Street, South Portland, Maine with **MORTGAGE COVENANTS**, to secure the payment of **TWO HUNDRED TWENTY-FIVE THOUSAND (\$225,000.00) DOLLARS** with 5.12111 percent interest per annum payable in monthly installments as set forth in a certain promissory note of even date, the land in Portland, Cumberland County, State of Maine, situated at 94 Pleasant Avenue, Portland, County of Cumberland, State of Maine, and described as follows:

This mortgage being subject to a Mortgage from **FLOYD R. RUTHERFORD** and **BEVERLY A.
