- **Permits expire in 6 months. If the project is not started or ceases for 6 months.**

- **Per Section 107.3.1 of the Maine Uniform Building and Energy Code (MUBEC). One set of printed approved stamped construction documents shall be kept at the site of work and shall be open to inspection by building officials.**

Any change of use shall require a separate permit application for review and approval. 2) This approves the repair or rebuild of the porch and entry steps within the existing non-conforming footprint. 3) Separate permits are required for any electrical, plumbing, sprinkler, fire alarm, HVAC systems, heating appliances, including pellet/wood stoves, commercial hood exhaust systems, fire suppression and fuel tanks. Separate plans may need to be submitted for approval as a part of this process. 4) This permit is being approved on the basis of plans submitted. Any deviations shall require a separate approval before starting that work.
